The Protection Fraud Network used Computer System Frauds against Big Business for Profit Frauds. They used Computer frauds against the State for profit Frauds and to finance Top Level Bribery. The Budget Frauds against the State used Work Records for 1 Contract for All Contacts in the Budget Fraud Set. It used Project Failure for Case Closure + Accountability Closure. It used Recruiting Process to identify and

eliminate anyone who was an Exposure Risk. Citizen Mr Zarb achieve Career Maturity as a Computer Expert. Recruiting Assessments for the State, and then Reuters, discovered he was a Committed Christian and had a Low Stress Threshold. It got an Exposure Risk Finding + Secret Market Exclusion Fraud that denied him access the State Market and Global Corporate Market. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. Equity Lawyer Mr Ellis used it for a Corruption Notice to the Crown and Parliament. It got revived use of the Coronation Oath Enforcement Authority It started a Corruption Remedy process that has continued ever since. It needed to achieve Total Destruction of the Protection Fraud Network. It got a Forced Resignation from prime Minister Mr Blair. It used exposure of the Expense Account Scandals timed to coincide with the 2009 Local Election Campaign Period to execute Dismissal Decisions against Prime Minister Mr Brown and the Labour Governing Majority. It got Full Co-operation from Prime Minister Mr Cameron, Deputy Prime Minister Mr Clegg and Opposition Leader Mr Miliband. The 2015 Parliament Session Priority was the Set Conditions for Fraud Findings + Dismissal Cases against Law Court Judges. It used a Fraud Invalidity Universal Precedent + Conflict Disqualification Universal Precedent + Automatic Issue Rights for the Citizen against the State, Profession Authorities and Law Courts. Citizens filed Corruption Claims that forced Corrupt Officers to choose between making Conflict Disqualification Admissions and committing Conflict Qualification frauds to get the Case Control needed for Process Denial Frauds + Dismissal Frauds + Restraint Frauds against the Citizen. The Set Up Period was 1 Year. Prime Minister Mr Cameron used it for the European Referenda, led the Remain Campaign, lost and resigned. It was an Honourable Resignation. The Protection fraud needed to stop the Judge Dismissals. They bought Leadership Votes for MP Mrs May because she was one of them.

Prime Minister Mrs May and the Protection Fraud Network required New Fraud Commitment Proof from Protection Fraud Beneficiaries. The Case Frauds against Citizen Mr Zarb were the Fraud Commitment Proof from the Computer Contract Fraud Managers. The Corruption Remedy Process got Confidence Collapses that got Case Delays. The 2021 Parliament Session Priority was Remedy Delivery. Session Priority Tests got Corruption Proof against the State and Profession Authorities, Remedy Denial Fraud Proof against the Law Courts and Protection Fraud Proof against the Cabinet, Prime Minister Mr Johnson and Opposition Leader Sir Keir Starmer. Session Priority Tests by Citizen Mr Zarb got a Confidence Collapse by Top Judges and Total Denial of Fraud Appeal QB 2018 000239 by the High Court. The County Court Sale Enforcement Claim Fraud F00LE923 got Audio Records that are QB 2018 000239 Case and Costs Order Denial Proof Presentation Proof + QB 2018 000239 Costs Enforcement Claim Proof + Contempt Remedy Denial Fraud Proof against the Hearing Judge. 2 By Elections Defeats on 23rd June 2022 got Confidence Collapses, Renewed Efforts in Parliament to complete the Dismissal Process against Prime Minister Mr Johnson and the QB 2018 000239 Case Admission that is evidenced by the Full Transcript Refusal Fraud by Justice Mrs Stacey.
