The Contempt Fraud Appeal QA 2022 000007 Dismissal Hearing Refusal Fraud + Without Hearing

Dismissal Fraud on 24<sup>th</sup> June 2022 with Day 4 Seal of High Court Justice Mr Soole

Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

Representations

Partition got Sovereign Independence for India and control of the Law Courts for the Protection Fraud Network. Corrupt Immigrants discovered they could buy UK Court Frauds against Family Members and Others. The Fraud Conspiracy Proof for Citizen Mr Sood includes Contempt Immunity Fraud + 8 MPH Excess Speed Case Stated Appeal Jurisdiction Denial Fraud by the Magistrates Court and High Court

Remedy Proposals

1. Case Priority Finding for the Corruption Case of the Citizen against All Other Cases
2. Corruption Case Finding + Priority Entitlement Finding + Bias Finding + Fraud Finding + Conspiracy Finding + Contempt Finding + Appeal Strike Out Revocation Order for Citizen Beneficiary Mr Sham Pal Sood against the High Court Appeals Office for the Stated Reason that:
  - 2.1. The Top Corruption Controls are the Coronation Oath for Equity Governance using the Common Law, the Corruption Remedy Priorities for each Parliament Session that are decided by the Coronation Oath Enforcement Authority, and General Elections that change Governing Majorities and prevent Power Concentration in Small Minorities.
  - 2.2. The 2021 Parliament Session Priority was Remedy delivery. Test Cases got Corruption Proof against the State and Profession Authorities, Remedy Denial Fraud Proof against the Law Courts and Protection Fraud Proof and Election Fraud Proof against the Cabinet, Prime Minister and Opposition Leaders. It denied a Credible Choice for Voters and invalidated use of the Ultimate Sanction of a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof. It created the need for a Convention Busting Proof Set to validate a Coalition Government + Cabinet + Prime Minister to manage Corruption Remedies starting with Dismissal Decisions against Top Judges. Equity Lawyer Mr Ellis prepared cases to get the Convention Busting Proof Set.
  - 2.3. The Protection Fraud Conspiracy by the Cabinet, Prime Minister and Opposition Leaders used Intimidation Frauds against Corruption Witnesses and Corruption Victims. They used a £146,000 Backdated Income Tax Charge Fraud + an Excess 8 MPH Speed Framing Fraud + Civil Court Frauds against Citizen Mr Sood. The Excess Speed Case Statement Fraud Appeal got Appeal Advice Fraud Proof against the Magistrates Court and the High Court.
  - 2.4. The Contempt Fraud Appeal 2022 000007 Bundle dated 14th March 2022 is 21 pages long. It consisted of the Appeal Documents List that appears in the Schedule and a Sample Documents Notice of 20 more pages
