

The Case Issues are:

1. Trust Accountability Rights of the Beneficiaries against the Trustee and Trust Lawyer
2. Negligence Settlement Enforceability by the Beneficiary Client against the Trust Lawyer
3. Contempt Accountability Rights of the Victim against Parties, Representatives and Court Officers

Brief Family Trust Explanation

In 1947 Partition got Sovereign Independence for India. The Protection Fraud Network got control of the Indian Courts. In 1967 the UK discovered how much control the Protection Fraud Network had. A number of lawyers had the choice of offending the Protection Fraud Network by refusing Judicial Office, or accepting it and taking a Murder Risk of staying honest, or accepting it and going corrupt to satisfy the Protection Fraud Network, or fleeing the jurisdiction. 10 of them led by Mr Ned Chaudhari fled the jurisdiction. The Indian Protection Fraud Network sold Court Frauds for Family Members against Family Members. Corrupt Migrants brought with them to the UK a Market Demand for Court Frauds. The UK Protection Fraud Network developed the Family Fraud Market.

The Dictator Governance Plan used Sabotage Frauds against the Coronation Oath Enforcement Authority. Criminal Conspiracy proof against a serving Prime Minister was needed to get revived use of it. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders. Equity Lawyer used for a Corruption Notice to the Crown and Parliament. It got revived use of the Coronation Oath Enforcement Authority and a Corruption Remedy Process that has continued ever since. It used Victim Cases for Corruption Investigations and Damage Research. It discovered that Illiterate Immigrants with a Limited Education and Limited Language had Extreme Vulnerability. All Families have a Family Fraud Risk. On 28th January 2022 the Equity Lawyer Mr Ellis explained the Family Fraud facts to the Security Manager of Snaresbrook Crown Court, who laughed and said 'that is what Asians do'. On the evidence available the Family Fraud Risk is greater for the Asian Community.

Citizen Mr Sham Pal Sood was born in late 1952 into a Respectable Poor Indian Family and had Limited Education. In 1976 he came to UK with No English for an Arranged Marriage. He had successes with employment and marriage and had 4 children. He bought a house. The Language Advantages made his wife the Lead Authority Figure for the children. Medical Negligence got an early death for her, loss of the Lead Authority Figure for the Children, Child Care Sole Responsibility for him. He did not appreciate the Family Fraud Risk. He did not know Trust Success needs the Trustee to have Asset Management Skills and the Beneficiary to have Trust Accountability Skills. He used

Medical Negligence Damages to found a Family Estate with Trustee Appointments for 2 Elder Sons. He was an Obvious Targets for Trust Fraud Advice from Fraud Business Manager to Both Sons.

The Trustee Sons, Business Touts and Law Court Judges were unlucky with the timing.

The Fraud Business Managers used Finance Professionals to get Client Wealth Details and identify Ruin Fraud Targets. An Equity Standard Investigation is needed to discover precisely what passed between the Trustee Sons and the Fraud Business Managers.

The 2015 Corruption Remedy Priority was Set Up Conditions for Dismissal Cases against Law Court Judges. The Set Up Period was 1 year. In May 2015 the Younger Trustee Son got issue of a Trust Claim Fraud. It got a Complete Set of Fraud Conspiracy Proof for the Father against the Trustee Son, Lawyers, Court Officers and Law Court Judges. It got a Confidence Collapse for Case Closure by Law Court Judges. Prime Minister Mr Cameron used the Set Year for the European Referenda, lost and resigned. The Protection Fraud Network needed to stop the Dismissal Cases against Law Court Judges. They bought Leadership Votes for MP Mrs May because she was one of them. The Finance Profession Status made the Sood Family Cases a Bad Risk. On the evidence available Fraud Completion Delays were a Self – Defence Effort by Low Rank Judges.

In January 2020 the Father gave a Privilege Waiver, Confidentiality Waiver and Case Use Authority. It enabled Case Management by Equity Lawyer Mr Ellis. Case Management by the Equity Lawyer for Citizens, including Mr Sood, got Corruption Proof against the State and Profession Authorities, Remedy Denial Fraud Proof against the Law Courts. The Crown used it for Trial Orders for Unfitness Cases and Dismissal Decisions against Law Court Judges with Execution responsibility findings against the Cabinet. Dismissal Failures were Protection Fraud Proof against the Cabinet. It got Unfitness Dismissal Decisions against Prime Minister Mrs May and Mr Johnson that got Protection Fraud Proof against most of the Governing Majority and Opposition Minority including Opposition Leader Sir Keir Starmer. 2 By Election Defeats got a Forced Resignation from Prime Minister Mr Johnson.

The Trust Fraud Claim got Order Breach Contempt Fraud Proof against the Younger Trustee Son and a Contempt Immunity Fraud Appeal to the Court of Appeal.

The Corruption Remedy Process needs cases to set Deterrent Precedents against Trustees and Lawyers. The Sood Family Cases are excellent for the purpose. Negotiation Offers by the Equity Lawyer for Immunity Terms in exchange for Full Disclosure about the Court Frauds got Remedy Co-operation Refusal Proof against the Trustee Sons and Lawyers. The Equity Lawyer expected the Resignation Refusals by Prime Minister Mr Johnson to get Print Delays of the Allocation Hearing Notice. It got a 153 Day Delay. The Court has Case Documents that make Remedy Proposals for the Father
