It needs an Election Fraud Investigation of the Leadership Contest

Question Tests will discover whether Elected Politicians help Voters with Office Fitness Enquiries

The Case Headings get Admissible Evidence Status for the document and the Remedy Process

Citizen Mr Edward Ellis + Chelmsford Councillor Mr Barry Knight + Chelmsford MP Ms Vicky Ford

Polite Request from the Citizen to the Councillor and MP that they do themselves, or by agents, use a Leadership Contest Event to ask the Candidate Questions and give a Response Notice to the Citizen

1. Do the Leadership Candidates intend to get an Adjourned Debate to receive the Corruption Investigation Report and a of the Labour Government and for the Osteopath Profession?
2. Do the Leadership Candidates intend to get a Murder Investigation in the Miss Sunaina Chaudhari Case?

Question Reasons:

The Pharmaceutical Industry bought Market Frauds for Drug Treatment against Other Treatment. One was the creation of the General Osteopathic Council to Manage Market Frauds against the Osteopath Professions. In 2000, Corruption Complaints in more than 200 Constituencies got a Corruption Debate, an Investigation Commitment and a Pending Investigation Adjournment. It coincided with the Sunaina Chaudhari Case that exposed the Human Organ Scandal. She was ta 1st Maternal Cousin of a 1st Paternal Cousin of Leadership Candidate MP Mr Sunak.

The Genome Project got High Prices for Human Organs that were Genetic Defect Evidence. Killer Doctors used Foetal Scans that were Development Defect Proof for Diagnosis Frauds and Prognosis Frauds for Prescription Frauds. They used Abortion Frauds to get Abortion Material. They used Caesarean Section Births under Full Anaesthetic to get an Unconscious Period for the Mother and used that for Baby Murder, and then Human Organ Thefts. A Foetal Scan was Diaphragmatic Hernia Evidence. The Advice Frauds by Killer Doctors got an Abortion Refusal, Full Anaesthetic Refusal and Caesarean Section Birth Refusal by the Mother denied Abortion Material and a Murder Opportunity. The Mother insisted on a Diaphragmatic Hernia Operation. The Killer Doctors used the Discharge Plan for the Murder Set Up Conditions. It included a Small Dose of an Unlicensed Dug for anyone under the age of two. They got Healthy Baby Record for Operation Statistics and then used a Lethal Dose of the Unlicensed Drug with intent to Home death. The Mother got an Emergency Admission to the Local Hospital. The Killer Doctors made a Blame Mother Plan. It used a Lower Lethal Dose to prolong the Death Process and a Munchausen by Proxy Diagnosis Fraud against the Mother. The Maternal Aunt was in Cancer Recovery and visited Mother and Baby every day. She had Murder Suspicions, asked the Hospital Consultant 'are you killing the baby?' He smirked and then realised who had asked. He abandoned the Blame Mother Plan and got an Opinion Fraud from Great Ormand Street Hospital. It used a Genetic Defect Diagnosis Fraud + Doomed Life Prognosis Fraud + Mercy Killing Prescription Fraud. The London Borough of Redbridge Council and Law Courts used it for a Child Protection Fraud + Mercy Killing Order. Human Organ Thefts left the Chaudhari Family with the Genetic Evidence of the Skin Covered Skeleton.

A Protection Fraud Deal got an Investigation Denial Fraud + Accountability Denial Fraud for the Pharmaceutical Industry and 2001 General Election Campaign Finance for Prime Minister Mr Blair. The Death Inquest + Connected Cases got Protection Fraud Conspiracy Proof against the State and Law Courts. The Chaudhari Family kept the Body Remains in hope of Corruption Remedies. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. Equity Lawyer used it for a Corruption Notice to the Crown and Parliament. It got revived use of the Coronation Oath Enforcement Authority after a Dormancy Period of 45 years. It started a Corruption Remedy Process that has continued ever since. The Election Fraud Cover Up got Corruption Proof against the State, Remedy Denial Fraud Proof against the Law Courts. It got Dismissal Priority Finding against Law Court Judges and Execution Responsibility Finding against the Cabinet. Dismissal Failures were Protection Fraud Proof against the Cabinet. It got a Remedy Failure Finding + Unfitness Finding + Dismissal Priority Finding against Prime Minister Mr Blair. In 2006 he signed a 10 Months Retirement Notice to avoid a Parliament Session Refusal and Forced General Election with Mass Publicity for the Fraud Proof against him. He used the Notice Period to arrange Protection Frauds in hope they would last his lifetime. He issued a Destruction Order of the Sunaina Chaudhari Body Remains. An Execution Failure enabled a Body Remains Export by the Chaudhari Family to India. A Death Inquest Claim by the Mother got a Valid Claim Finding + Body Remains Preservation Order + Out of State Death Inquest Jurisdiction Deficit Finding + Jurisdiction Increase Case Reference by the High Court to the Supreme Court, Law Commission and Parliament. Jurisdiction Increase Legislation enabled a Protection Fraud Deal got Accountability Denial Frauds for the Pharmaceutical Industry in exchange for Massive Investment in the Indian Pharmaceutical Industry. The Accountability Denial Frauds needed Death Inquest Delays Frauds until the Mother died and then Probate Estate Representation Frauds to get a Death Inquest Withdrawal Fraud and a Body Remains Destruction Consent Fraud. A Protection Fraud Sabotage Plan used a Will of the Mother for an Executor Appointment of the Equity Lawyer that got Key Witness Status for him in the Estate Representation Frauds. The Mother died. The Equity Lawyer got Estate Representation Fraud Conspiracy Proof against the Law Courts. It was part of the Proof Set that got the Protection Fraud Proof against the Cabinet, Prime Minister Mr Johnson, Cabinet, and most of both the Governing Majority and Opposition Majority including Opposition Leader Sir Keir Starmer. Local Election Defeats and By Election Defeats got a Confidence Collapse and more than 50 Government Office Resignations. They got a Forced Resignation from Prime Minister Mr Johnson and a Leadership Contest with the Candidate Statis for the Paternal 1st Cousin of the Maternal 1st Cousin of the Baby Murder Victim, Sunaina Chaudhari. The Pending Investigation Adjournment of the Corruption Debate made the General Osteopathic Council and Obvious Target for a Corruption Remedy Process of the Coronation Oath Enforcement Authority. It needed a Smoking Gun Proof Set that linked the State, Profession Authorities, Law Courts, Cabinet, Governing Majority and Opposition Minority. In 2016 and 2022 Citizens Ms Lewis and Ms Davies got Smoking Gun Proof Sets. It is Protection Fraud Damage Proof against Parliament. It enables Integrity Tests of the Leadership Contest and Leadership Candidates.
