In 2021 Dismissal Decisions against Prime Minister Mr Johnson got Protection Fraud Proof against the Cabinet, most of the Governing Majority and Opposition Minority including Opposition Leader Sir Keir Starmer. In 2012 the Remedy Process got Protection Fraud Proof against him when he was Director of Public Prosecutions. He kept the Prime Minister in office while using the Party Gate Scandal as Apparent Opposition.

The made an Election Fraud Plan. It used Revenue Termination Blackmail by the Cabinet and Big Business to get Protection Fraud Non-Disclosure Propaganda Services from the BBC and Independent Television Election Integrity Tests by the Equity Lawyer got Election Fraud Findings. The 2022 Local Election Defeats did not get the Confidence Collapse needed for a Forced Resignation from Prime Minister Mr Johnson.

A Health Fraud Risk was obvious. The Pre-emptive Remedy was a Written Notice from the Equity Lawyer to Professor Ali and Oral Notice to the Renal Team that they had Incredible Target Status for a Criminal Investigation into the Attempted Murder of the Equity Lawyer in April 2022.

The 2 Bye Election Defeats on 23rd June 2022 got 50 Government Office Resignations and then a Forced Resignation from Prime Minister Mr Johnson.

The Leadership Contest Integrity Tests by the Equity Lawyer got Election Fraud Findings

The Equity Lawyer had Concentration Difficulties and brought forward the Key Test. It was Questions Advice for MPs masked as Polite Requests from Constituents. The Royal Commission Email on 5th August 2022 to the Royal Commission Address List + All MPs gave the Questions Advice and got 104 Response Emails. Some were multiple replies of 80 and 29 and lower numbers. The Equity Lawyer copied some of the Reply Records into word for the Lord Bishops and went to bed. About 18 hours later he discovered All Replies had been deleted. The History + Case Circumstances raise a Computer Hacking + Records Deletion Presumption against the Secret Service and Cabinet that is subject to Rebuttal Proof. There is no point removing the Reply Details from the Sending Account and leaving the Receiving Account in-tact. The Election Frauds were against the leadership Contest Voters and All MPs.

Health Frauds include the use of Poison Frauds to Compromised Performance and time for the Infection Frauds to get Distraction Evidence for the Diagnosis Process.

The Equity Lawyer had got the Best Evidence before the Gastric Illness Damage

The last Normal Intake was the Dialysis Treatment Breakfast on Tuesday 9th August 2022

The Consumption Record starts with the Dialysis Session Breakfast = 550 calories + Wednesday 0 calories + Thursday 120 and 250 and 370 = 740 calories + Friday 250 and 185 and 200 = 635 + Saturday 550 and 100 and 185 = 835 + Sunday 200 and 185 and 320 = 705 at 1500 hours
