Royal Commission + Polite Request + Best Advice from Equity Lawyer to MPs 14th August 2022

Polite Request that MP Mr David Davis and MP Mr Edward Miliband

1. Explain to ALL MPs that
 - 1.1. The Lord Bishops has the evidence for a Leadership Contest Election Fraud Finding against the Cabinet, Prime Minister, Opposition Leader and House of Commons Speaker
 - 1.2. A Contest Result will get an Official Seals Surrender by Prime Minister Mr Johnson
 - 1.3. An Election Fraud Finding Pronouncement Delay will enable the Crown to appoint as Replacement Caretaker Prime Minister anyone who can form a Corruption Remedy Coalition Majority
 - 1.4. The Lord Lieutenants have the Neutrality Qualification to host Corruption Remedy Plan Meetings for MPs who want to make Immediate Progress.
2. Investigate the possibilities of a Corruption Remedy Coalition
3. File Joint Finding Reports with the Crown

Best Advice that the Leadership Contestants MP Ms Truss and MP Mr Sunac

1. Get a Contest Result and Forced Office Seals Surrender from Prime Minister Mr Johnson.
2. Either separately or together do what they can to service the Corruption Remedy Process and salvage the Conservative Party for the Reasons that most of the Conservative Party Membership have a Value System that includes Just Government. They are going to discover:
 - 2.1. Top Police, Top Customs and Top Judges are the Top Drug Dealers sold Drug Supplies with Protection Frauds that extended as far as Child Prostitution.
 - 2.2. Between 2010 and 2015 Full Co-operation from Prime Minister Mr Cameron, Deputy Prime Minister Mr Clegg and Opposition Leader Mr Miliband gave the Coronation Oath Enforcement Authority the confidence they could rely on whoever won the 2015 General Election for Corruption Remedies. The 2015 Parliament Session Priority was Judge Dismissal Conditions. They required Universal Precedents that apply in every case, that Fraud invalidates everything and gets a new process, and a Conflicted Interest is Neutrality Obligation Breach and Conflict Jurisdiction Disqualification from Investigator, Prosecutor, Defender, Trial Adjudicator and Appeal Adjudicator, and Case Issue Rights for the Citizen against the State and Law Courts
 - 2.3. The Set Up Period was 1 Year. Prime Minister Mr Cameron used it for the European Referenda, led the Remain Campaign, lost and resigned. It was an Honourable Resignation. The Protection Fraud Network needed to stop the Dismissal Executions against Corrupt Judges. They bought Leadership Votes for MP Mrs May because she was one of them. In 2019 Corruption Findings got a Forced Resignation from Prime Minister Mrs May. A Leadership Contest deal got Support Votes for MP Mr Johnson in exchange for Protection Frauds for Corrupt Judges. Prime Minister Mr Johnson delivered Protection Frauds for everything including Child Prostitution.
 - 2.4. Conservative Party Members need time to absorb this. They might find it easier if they hear it from both of the Leadership Contestants.
