2. The Constituency Email Address Services provided by Redbridge Council for MP Mr Wes Streeting deter Hainault Constituents from making Local Authority Service Complaints about them to him.
3. The Representation Refusal of Folkestone and Hythe Constituents by Former MP Mr Michal Howard because a 2005 General Election Management Agreement between him, as Opposition Leader, and Former Prime Minister Mr Blair required Representation Refusals by them thereafter.
4. Representation Services for the Pharmaceutical Industry by MP Ms Dorries denies Credibly Reliable Representation for Mid Bedfordshire Constituents in the Suspicious Circumstances that Licence Revenue Termination Blackmail by her, as Secretary of State for Culture, Digital, Media and Sport got Issue Non-Disclosure Services by the BBC in the 2022 Local Elections and the Leadership Contest
