The Best Advice for the Metropolitan Police Commissioner, Secretary of State for Justice and Leadership Contestants is Mass Publicity for Case Issue Consents and Interim Remedy Consents that force the Administrative Court to choose between Fraud Enforcement and Fraud Remedies for the Stated Reasons:

1. Exposure Management of Election Fraud Scandal needs Simple Documents many people can read and understand. The Best Advice to the Defendants, Interested Parties and MPs are some of the Simple Documents. Journalists publish Simpler Explanations when free from Election Fraud Blackmail
2. The 2019 Parliament Session Priority was Remedy Proof for the Law Courts or Criminal Conspiracy Proof for Special Measures Decisions against the State, Profession Authorities and Law Courts with Mass Publicity for Corruption Findings and Dismissal Decisions against Law Court Judges. Test Cases got the Criminal Conspiracy Proof.
3. The Ruin Frauds against Citizen Mr Nkrumah got the Complex Fraud Proof Sets needed for the Special Measures Decision against the Metropolitan Police, Essex Police, Barking and Dagenham Council, Professional Authorities and Law Courts with a Priority Decision against the Metropolitan Police
4. The 2021 Parliament Session Priority was Remedy Delivery. Judge Dismissal Failures got Protection fraud Proof against the Cabinet, Prime Minister Mr Johnson, most of the Governing Majority and most of the Opposition Minority including Opposition Leader Sir Keir Starmer. They made an Election Fraud Plan. It used Revenue Termination Blackmail by the Cabinet and Big Business to get Protection Fraud Non-Disclosure Propaganda Services by the BBC and Independent Television. It did not stop the 2022 Local Election Defeats for the Governing Majority.
5. The 2022 Parliament Session Priority is Remedy Delivery. It needed a Forced Resignation from Prime Minister Mr Johnson. 2 By Election Defeats got more than 50 Government Office Resignations and the Forced Resignation on 7th July 2022.
6. Cabinet Office got Protection Fraud Joint Liability and Election Fraud Joint Liability for the Secretary of State for Justice and Leadership Contestants.
7. Claim Filing got an Issue Denial Fraud and Issue Case Reference by the Administrative Court Officers to a High Court Justice that is evidenced by the Case Email in the Schedule
8. Claim Filing got a Claim Acknowledgment and Case Allocation Notice from the Metropolitan Police
9. Corruption Allegations are a Conflicted Interest that get a Conflict Jurisdiction Disqualification and Remedy Only Jurisdiction Limit for the Citizen against the State and Law Courts.
10. Special Measures get Personal Accountability by the Metropolitan Police Commissioner for the Ruin Fraud Enforcements against Citizen Mr Nkrumah
