- 1. Jurisdiction Superiority Findings:
 - 1.1. for the Parliament Session Jurisdictions of the Citizen, Crown, Lord Archbishops and Lord Bishops collectively known as the Coronation Oath Enforcement Authority against the Inferior Jurisdiction of Parliament
 - 1.2. Parliament against the Inferior Jurisdictions of the Law Courts
 - 1.3. The Law Courts against the Inferior Jurisdictions of the State and Profession Authorities
- 2. Superior Jurisdiction Pending Remedies Protection Finding for the Citizen against All Inferior Jurisdictions for the Self-Evident Reason that
- 3. Priority Finding for the Integrity Test Case of the Citizen against All Cases of the State, Profession Authorities and Law Courts for the Stated Reason that Integrity Test Cases of the Citizen get Proof Sets that meet the Corruption Remedy Proof Standard and are Admission Evidence for Parliament Session Decisions by the Coronation Oath Enforcement Authority
- 4. Integrity Test Findings for Contempt Fraud Appeal 2022 001411 against the Court of Appeal for the Stated Reason that:
 - 4.1. The Parliament Session Jurisdictions of the Citizen, Crown, Lord Archbishops and Lord Bishops are collectively known as the Coronation Oath Enforcement
 - 4.2. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. Equity Lawyer Mr Ellis used it for a Corruption Notice to the crown and Parliament. It got revived use of the Coronation oath Enforcement Authority after a Dormancy Period of 45 years. It got a Corruption Remedy Process that has continued ever since. It got Corruption Proof against the State, Remedy Denial Fraud Proof against the Law Courts and Protection Fraud Proof against Cabinets. The Remedy Penalty was Dismissal Decisions against Prime Ministers Mr Blair, Mr Brown, Mrs May and Mr Johnson. A Dismissal Help Request by Government Majority Back Benchers got a Request Refusal by Opposition Leader Sir Keir Starmer because a Drug Crimes Integrity Test got Protection Fraud Proof against him in 2012 when he was Director of Public Prosecutions. Top Police, Top Customs and Top Judges are the Top Drug Dealers. Top Drugs Sales have Protection Frauds that, in the cases of Rotherham and elsewhere, includes Child Prostitution and Everything Else. The Absolute Priority of the Cabinet and Opposition Leader is Protection Frauds for Child Prostitution and Everything Else. The Order Breach Contempt Immunity Frauds of the Law Courts for the Trustee Son against Citizen Mr Sham Pal Sood.

Appeal Regulation Waiver for Citizen Mr Sham Pal Sood against the Trustee Son Mr Vishal Sood for the Stated Reason Citizen Mr Sood is a Legal Immigrant with Limited Literacy and Case Management Dependency on Equity Lawyer Mr Ellis. Kidney Failure and a Serious Infection create a Limited Physical Capacity for him to service the Remedy Process Cases. A Regulation Waiver is a Just Remedy
