A Dismissal Help Request by Governing Majority Back Benchers got a Request Refusal by Opposition Leader Sir Keir Starmer. In 2012 an Integrity Test got Protection Fraud Proof against him when he was Director of Public Prosecutions. The Shared Priority of the Cabinet and Opposition Leader was Protection Fraud Concealment for themselves and Protection Fraud Exposure against Law Court Judges. Revenue Termination Blackmail by the Cabinet and Big Business got Protection Fraud Non-Disclosure Propaganda Services from the BBC and Independent Media. Remedy Delivery Priority required the Cabinet to get Hearing Audio Records as Personal Responsibility Proof against Identifiable Individuals. Restraint Renewal Claim Fraud Claim CO 0612 2022 against the Equity Lawyer was Protection Fraud Reassurance needed to get Audio Record Proof against Law Court Judges. A Secret CO 0612 2022 No Further Action Decision denied Hearing Audio Proof against the Cabinet. In 2000 the Hospital Murder + Human Organ Theft against 5 Months Old Sunaina Chaudhari motivated a Protection Fraud Deal ion UK that used Death Inquest Frauds + Other Court Frauds and a Protection Fraud Deal in India that used Death Inquest Delays in India until the Mother, Sadhana Chaudhari died, and then Probate Estate Representation Frauds to get a Death Inquest Claim Withdrawal Fraud + Body Remains Destruction Consent Fraud.
  - 4.2. The Ministry of Justice used a Romford County Court Office Space Licence as Legal Service Credibility Proof that enabled Known Dangerous criminal Mr Winston Leachman to function as a Crime Business Managers for Top Judges. The Top Drug Dealers were and are the Top Police, Top Customs and Top Judges. Top Drug Sales go with Protection Frauds, that in the case of Rotherham

They appointed Mr Leachman. He and Junior Officers wanted Protection Frauds that would last their lifetimes. He committed Firearms Theft. They seized the Stolen Firearms, listed them and identified Mr Leachman as the Possessor in Receipt 0223607. They seized the Cabinet from which they were stolen, listed it and the comment 'locked - contents unknown' and identified the Lawful Possession Agent on Receipt 0233608. They went to Lewes Armoury with intent to putting the Stolen Firearms in the Cabinet and pretending nothing had happened. They had no key. The Stolen Firearms, Cabinet, Receipts, Armoury Records and Criminal Convictions of Mr Leachman that got a Statutory Prohibition against Firearms Possession and a Minimum Sentence of 5 Years' Imprisonment were Protection Fraud Conspiracy Proof against Sussex Police. Integrity Tests used the Proof Set to get Protection Fraud Proof against Sir Keir Starmer when he was Director of Public Prosecutions, and many others, including Prime Ministers Mr Brown, Mrs May and Mr Johnson.

The Ruin Fraud Conspiracy against Citizen Mr Akwasi Nkrumah got the Proof Set needed for Special Measures Decisions against the State, Profession Authorities and Law Courts with a Priority Decision against the Metropolitan Police.
