Representations

Citizen Ms Davies managed Corruption Investigations and Remedy Management Investigations for the Coronation Oath Enforcement Authority. She got Conflict Qualification Fraud Proof, Corruption Proof, Remedy Denial Fraud Proof and Protection Fraud Proof against the State, Profession Authorities, Law Courts, Cabinet and Parliament. Fraud Appeal Case Stated Applications by Citizens, including Ms Davies, got Criminal Conspiracy Proof against the Magistrates Court, Crown Court and High Court.

Confidence Collapses motivated Top Judges to commit Case Frauds to avoid Hearing Audio Records that are Personal Responsibility Proof against Identifiable Individuals for Known Court Frauds. Drug Research Frauds and Medical Murders for Human Organ Thefts made them particularly keen to avoid involvement in the Health Market Frauds. The General Osteopathic Council could not get or did not trust Protection Frauds from the Higher Courts and used the Osteopath False Description Criminal Prosecution Fraud in an effort to get Case Closure. They are too late. The Coronation Oath Enforcement Authority needs Integrity Tests of the Cabinet. It is one of the cases that are excellent for the purpose. The use of Administrative Decisions to commit Court Frauds validates Defendant Status for the Cabinet in Fraud Judicial Reviews.

1. The Pharmaceutical Industry bought Market Frauds for Drug Treatment against Other Treatment. One was creation of the General Osteopathic Council to manage Market Frauds against Registered Osteopaths. In 2000, Corruption Complaints in more than 200 Constituencies got a Corruption Debate, Investigation Commitment, Pending Investigation Adjournment. A Corrupt Deal got Protection Frauds for the General Osteopathic Council from Parliament in exchange for 2001 General Election Campaign Finance from the Pharmaceutical Industry for Prime Minister Mr Blair. Continuing Corruption made the General Osteopathic Council and Obvious Target for the Remedy Process of the Coronation Oath Enforcement Authority.
2. The December 2019 Parliament Session Priority was Remedy Proof for the Law Courts or Criminal Conspiracy Proof for Dismissal Cases against Law Court Judges. It needed Session Priority Test Cases to get Remedy Proof for the Law Courts or Remedy Denial Fraud Proof against them.
3. The 2021 Parliament Session Priority was Remedy Delivery. The Coronation Oath Enforcement Authority used the Proof Sets for Dismissal Priority Findings against Law Court Judges with Execution Responsibility Findings against the Cabinet. Dismissal Failures got Protection Fraud Proof against the Cabinet and the Default Penalty of a Dismissal Priority Decision against Prime Minister Mr Johnson. A Dismissal Failure was Protection Fraud Proof against most of the Governing Majority and Opposition Minority including Opposition Leader Sir Keir Starmer. Dismissal Help Requests by Governing Majority Back Benchers got Request Refusals by the Opposition Leader because an Integrity Test got Protection Fraud Proof against him. Protection Fraud Concealment was the Shared Priority of the Cabinet and Opposition Leader. They made an Election Fraud Plan. It used Revenue Termination Blackmail by the Cabinet and Big Business that got Protection Fraud Non-Disclosure Propaganda Services from the BBC and Commercial Media.
4. The Remedy Delivery needed Co-ordinated Corruption Proof for Special Measures Decisions against the State, Profession Authorities and Law Courts. The General Osteopathic Council was an Obvious Investigation Target to get .
5. A Patient Satisfaction Publicity Prohibition was a Market Frauds by the General Osteopathic Council for the Pharmaceutical Industry against Registered Osteopaths. A Market Complaint by Citizen Ms Davies motivated the General Osteopathic Council to commit a Conflict Qualification Fraud, Complaint Investigation Fraud, Mental Incapacity Presumption Fraud, Mental Examination Demand Fraud and use of an Examination Refusal for a Pending Investigation Registration Suspension Fraud and Trial Denial Fraud. Conflict Qualification Fraud Complaints and Claims by Citizen Ms Davies got Remedy Denial Fraud Proof against the

State, Profession Authorities Law Courts, Cabinet and Parliament. It was part of the Proof Sets the Coronation Oath Enforcement Authority used to decide the 2022 Parliament Session Priority of Remedy Delivery. It needed a Forced Resignation from Prime Minister Mr Johnson and Special measures Decisions against the State, Profession Authorities and Law Courts starting with the Metropolitan Police. Integrity Tests got Continuing Corruption Proof against the Metropolitan Police and Law Courts when Special Measures were in progress.

6. 2022 Local Election Integrity Tests got Prohibited Question Fraud Proof that was Election Fraud Conspiracy Proof for the Coronation Oath Enforcement Authority against the Media, Law Courts, Cabinet and Opposition Leader. The Cabinet ignored Local Elections Defeats.
7. The 2022 Parliament Session Priority is Remedy Delivery. It needed a Forced Resignation from Prime Minister Mr Johnson and Special Measures Decisions against the State, Profession Authorities and Law Courts with a Priority Decision against the Metropolitan Police. Integrity Tests got Fraud Continuity Proof for Citizens against the Metropolitan Police, Other State Authorities, Profession Authorities, Law Courts and Cabinet. Two By Election defeats got 50 Government Office Resignations and a Forced Resignation from Prime Minister Mr Johnson.
8. Leadership Contest Integrity Tests got Prohibited Questions Proof that was Election Fraud Conspiracy Proof for the Coronation Oath Enforcement Authority against the Media, Law Courts and Contest Managers. On 6th September 2022 the office of Prime Minister passed from MP Mr Johnson to the Contest Winner, MP Ms Truss.
9. The Priority Decision for the Regulation Enforcement Administrative Decision against the Profession Fitness Adjudication is Remedy Denial Fraud Proof and Protection Breach Fraud Proof. Other Cases got Fraud Continuity Proof + Protection Breach Fraud Proof for the Coronation Oath Enforcement Authority against the State, Profession Authority, Law Courts and Cabinet. It validates use of Fraud Remedy Claims that get either Remedy Proof for force the State, Profession Authorities, Law Court Judges, Cabinet Officers, Opposition Leader or Parliament or Fraud Conspiracy Proof for the Coronation Oath Enforcement against them.
