The Protection Fraud Network got control of the Cabinets of Prime Ministers Mr Blair, Mr Brown, Mrs May, Mr Johnson and Ms Truss. The Judicial Review is an Integrity Test that will get Remedy Proof for the Cabinet of Prime Minister Ms Truss or Protection Fraud Proof against them. The Coronation Oath Enforcement will use Fraud Proof for Parliament Session Decisions. The Ultimate Sanction is a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof, Remedy Denial Fraud Proof and Protection Fraud Proof

Fact Statement

The purpose of the Eviction Fraud is to get Physical Possession and Total Destruction of Original Records of the Sadhana Chaudhari Probate Estate that are stored at 450 new North Road, Hainault IG6 3EB. Medical Records are Murder Proof against Killer Doctors and Health Authorities, and Court Case Records are Murder Protection Fraud Proof against UK Law Courts and the Cabinets of Prime Ministers Mr Blair, Mr Brown, Mrs May and Mr Johnson. Protection Fraud Deals between the Pharmaceutical Industry and UK State used Death Inquest Frauds. Protection Frauds between the Pharmaceutical Industry, UK State and Indian State needed Baby Death Inquest Delays until the Mother died, and Probate Estate Representation Frauds to get a Death Inquest Claim Withdrawal Fraud and Body Remains Destruction Fraud. A Will Executor Appointment by the Mother for Equity Lawyer Mr Ellis made him the Key Witness in the Probate Estate Representation Frauds. On 6th December 2018 the Mother died. The Cabinets of Prime Minister Mrs May and Mr Johnson used General Civil Restraint Frauds against the Equity Lawyer for Probate Grant Denial Frauds against the Probate Estate. A Mortgage Purchase Offer by the Mother's Maternal Nephew, and service of it by the Equity Lawyer got No Response from the Bank of Scotland and then Mortgage Default Possession Claim H1PP8822. It was used for a Representative Appointment of Citizen Ms Berry. She did not have Management Capacity for a case of that complexity. A Case Explanation by the Equity Lawyer got Hearing Audio Records that are Personal Responsibility Proof against an Identifiable Claim Counsel and Identifiable Judges for the Representation Frauds and Remedy Denial Frauds against the Probate Estate. On 6th September 2022 the office or Prime Minister passed from MP Mr Johnson to MP Ms Truss. The Coronation Oath Enforcement Authority needs a Test Case of the Cabinet. The Eviction fraud is excellent for the purpose.

The Northern Ireland Peace Process revealed IRA Leaders were MI5 Agents. It got Assassin Risk Status for 65 IRA Prisoners. Parliament voted for a £2.5 Billion Budget that got Health Dictator Powers for Prime Ministers. All 65 IRA Prisoners died in what should have been the prime of their lives. On an unknown date Prime Minister Mr Blair sold use of Health Dictator Powers for whatever he could get. It enabled Medical Murders and Human Organs Theft. Killer Doctors used Development Defect Evidence for Genetic Defect Diagnosis Frauds, Doomed Life Prognosis Frauds, Abortion Prescription Frauds and Medical Murders. They used Caesarean Section Advice Frauds and Full Anaesthetic Advice Frauds to get an Unconscious Period for the Mother that Killer Doctors used for the Baby Murder. In 2000 the Sunaina Chaudhari Case got Medical Records that were Murder Proof against the Killer Doctors, Health Authority and Redbridge Council. They ignored Health Baby Evidence and used a Killer Dose of a Muscle Relaxant called Ranitidine, that did not have a Use Licence for anyone under the age of 2, to slow the heart and get Oxygen Starvation. They wanted a Home Death> The Mother, Mrs Sadhana Chaudhari, got an Emergency Admission to the Local Hospital. The Killer Doctors made a Blame Mother Plan. It used a Reduced Lethal Dose for a Slower Death that gave them time for a Murder Framing Fraud against the Mother using a Munchausen by Proxy Diagnosis Fraud. Everything that could go wrong for the Killer Doctors did go wrong. The Maternal Aunt, Ms Berry, had Pharmacy Qualifications for Retail, Hospital and Mental Health. Prime Minister Mrs Thatcher discovered use of Mental Health Patients for Drug Research Frauds. The Remedy was Mental Health Budget Starvation of Mental Health Hospital Decommissioning and No Action Protection Frauds for the Psychiatry Profession because she did not know how to manage Unfitness Remedies on the scale needed. The Maternal Aunt service the Decommission Contract of the Biggest Hospital. It had 2000 beds and outpatients. She had access to the files and patients and discovered Health Frauds on an Industrial Scale. The maternal Aunt was in Cancer Recovery and visited Mother and Baby every day. The Mother and Maternal Aunt both realised the Baby Murder was in progress but did not tell each other. The Munchausen by Proxy Investigation Fraud sile3nced Mother. The Maternal Aunt said to the Killer Consultant 'are you killing the baby?' He smirked and then realised who had asked. They ended the Munchausen by Proxy Investigation Fraud against the Mother and got from Great Ormond Street Hospital a Genetic Defect Diagnosis Fraud, Doomed Life Prognosis Fraud and Mercy Killing Prescription Fraud that bore the name of 5 Doctors and what appeared to be the signatures of 2. Redbridge Council used it for a Child Protection Order + Mercy Killing Order. The Medical Records and Body Remains DNA were Murder Proof. The Body Reasoning were Human Organ Theft Proof. The Court Records were Murder Proof and Murder Protection Proof. The Chaudhari Family kept the Body Remains in Redbridge Morgue in hope of Corruption Remedies.

In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. Equity Lawyer Mr Ellis used it for a Corruption Notice to Parliament and the Crown. It got revived use of the Coronation Oath Enforcement Authority after a Dormancy Period of 45 years. It got a Corruption Remedy Process that has continued ever since. It got Corruption Proof against the State, Remedy Denial Fraud Proof against the Law Courts, Dismissal Decision against Law Court Judges, Dismissal Failures that were Protection Fraud Proof against the Cabinet. The Default Penalty was a Dismissal Decision against Prime Minister Mr Blair. A Parliament Session Refusal Threat got a 10 Months Forced Resignation

Notice in 2006 from Prime Minister Mr Blair. He used the Notice Period to make Protection Fraud Arrangements that he hoped would last his lifetime.

One of the Protection Frauds was a Body Remains Destruction Order. An Urgent Body Remains Export by the Chaudhari Family from UK to India enabled the Mother to make a Death Inquest Claim. It got a valid Claim Finding + Body Remains Preservation Order + Out Of State Death Jurisdiction Deficit Finding + Jurisdiction Increase Reference from the High Court to the Supreme Court, Law Commission and Parliament that got Jurisdiction Increase Legislation. A Protection Fraud Deal got Accountability Denial Frauds for the Pharmaceutical Industry in exchange for Massive Investment in the Indian Pharmaceutical Industry. It needed Death Inquest Delays until the Mother died, Representation Frauds against the Probate Estate, a Claim Withdrawal Fraud, a Body Remains Destruction Consent Fraud and Original Records Destruction fraud. The Will Executor Appointment by the Mother of Equity Lawyer Mr Ellis got Key Witness Status for him in the Representation Frauds against the Probate Estate. His Case Management got Confidence Collapses, Protection Fraud Delays and use of the Eviction Fraud for an Integrity Test of the Cabinet
