

Royal Commission + Remedy Credibility Recovery Best Advice for the Media and Parliament 7<sup>th</sup> October 2022

The Best Advice is that Members of the House of Commons and House of Lords give a Leadership

Invitation to the Cabinet and Opposition Leaders to propose the Remedy Credibility Recovery Motion within 7 days, and if they do not do so, they propose it themselves for the Stated Reasons

The Best Advice is that the Media give Mass Publicity to the Entire Process from the Leadership Invitation, the Admissible Evidence and Valid Options for Parliament Session Decisions by the Coronation Oath Enforcement Authority, for the Stated Reasons:

1. The Long Process for a Dismissal Decision against a Prime Minister and a Governing Majority requires the Citizen to get Corruption Proof against the State and Remedy Denial Fraud Proof against the Law Courts, the Crown, Lord Archbishops and Lord Bishops to use Remedy Priority Findings that get Remedy Failure Protection Fraud Proof against the Cabinet, most of the Governing Majority and enough of the Opposition Minority that validates a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption proof, Remedy Denial Fraud Proof and Protection Fraud Proof.
2. The Short Process for a Dismissal Decision is Corruption Proof against the State and Cabinet.
3. The Short Process for a Parliament Session Refusal is Corruption Proof against the State, Cabinet and Opposition Leader.
4. The Long Process got Dismissal Decisions against Prime Ministers Mr Blair, Mr Brown, Mrs May and Mr Johnson. In 2021 Dismissal Help Requests from Governing Majority Back Benchers got Help Refusals by Opposition Leader Sir Keir Starmer. In 2012 an Integrity Test got Protection Fraud Proof against him when he was Director of Public Prosecutions. He and the Cabinet had the Shared Priority of Protection Fraud Concealment. They made an Election Fraud Plan. Mid Bedfordshire MP Ms Dorries is a Market Fraud Minder in Parliament for the Pharmaceutical Industry. The 2021 Cabinet Reshuffle got the office Secretary of State for Culture, Digital, Media and Sport so that she could service the Election Fraud Plan. It used Revenue Termination Blackmail by the Cabinet and Big Business got Protection Fraud Non-Disclosure Propaganda Services from the BBC and Commercial Media. Integrity Tests in the 2022 Local Elections got Fraud Proof against the Law Courts and Top Politicians. Local Election Defeats did not get a Forced Resignation from Prime Minister Mr Johnson. The 2022 Parliament Session Priority was Remedy Delivery. It needed Mass Publicity that the Rotherham Enquiry got Protection Fraud Proof against the Cabinet and Parliament, Special Measures Decisions against the State, Profession Authorities and Law Courts with a Priority Decision against the Metropolitan Police. It needed a Forced Resignation from Prime Minister Mr Johnson. On 23<sup>rd</sup> June 2022 Two By Election Defeats got a Confidence Collapse and mor than 50 Government Office Resignations that on 7<sup>th</sup> July 2022 got the Party Leadership Forced Resignation from Prime Minister Mr Johnson. Television News included Candidate MP Ms Truss appearing with Media Secretary of State MP Ms Dorries. It was a Secret Signal that confirmed a Protection Fraud Deal and Propaganda Guarantee. The Office Unfitness was Total Irrelevant to the Deal Makers. Power Obsession compromised the judgment Candidate Team and Protection Fraud Obsession compromised the judgment of the Protection Fraud Team. Candidate MP Mr Sunak has a Paternal 1<sup>st</sup> Cousin who is a Maternal 1<sup>st</sup> Cousin of the Murdered Baby whose case exposed Human Organ Theft Murders in 2000. Most of the Anglo-Saxon Population knew about the

Baby Organ Scandal but not much more. NHS Gossip informed NHS Staff. Most of them did not know who to tell except each other. The Asian Community knew enough to have Protect Marches. Candidate Mr Sunak might have had the decency for a Protection Fraud Deal Refusal. The Family Connection might have been enough to eliminate him as a Negotiation Target. The Propaganda Frauds imposed a Crippling Limitation on him in the Campaign Period but failed to get a Landslide Leadership Majority for MP Ms Truss. Political Incompetence caused a Financial Crisis.

5. A Short Process is in progress against Prime Minister Ms Truss and Opposition Leader Sir Keir Starmer.
6. Corruption Proof and Incompetence Proof against the Cabinet and Opposition Leader creates a need for All Parliamentarians to get Personal Credibility Proof.
7. The Remedy Credibility Recovery Motion Proposal to All Parliamentarians is Politically Neutral. It will Relevant Evidence for Parliament Session Decisions by the Coronation Oath Enforcement. They have the Proof Sets needed for a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof, Remedy Denial Fraud Proof and Protection Fraud Proof. Election Freeness and Fairness needs a Credible Choice for Voters. It needs either a Remedy Coalition in the Current Session or Remedy Campaigns by Renegade Party Candidates and Independent Candidates.

Remedy Credibility Recovery Motion for:

1. Education Policy Changes that give Immediate Mass Publicity to the Corruption Control Powers of the Citizen, Crown, Lord Archbishops and Lord Bishops, and
  - 1.1. The Long Process that uses Integrity Tests that get Justice Proof for the Authorities at some stage in the process or Corruption Proof against the State, Remedy Denial Fraud Proof against the Law Courts, Dismissal Decisions against Law Court Judges that get Protection Fraud Proof against the Cabinet with the Default Penalty of a Dismissal Decision against the Prime Minister, get Protection Fraud Proof against most of the Governing Majority and the Opposition Majority that validates a the Ultimate Sanction of a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof, Remedy Denial Fraud Proof and Protection Fraud Proof.
  - 1.2. The Short Process that uses Protection Fraud Proof Joint Liability against a Previous Cabinet and Administrative Decisions for Fraud Remedy Cases against the State and Cabinet to get a Fast Track Dismissal of the Prime Minister and the Ultimate Sanction.
2. Corruption Control Powers for the Citizen against the Devolved Authorities that are equal to those against the UK Authorities
3. Protection Enforcement + Contempt Fraud Liability Findings + for Citizens whose cases for the Coronation Oath Enforcement Authority
4. Probate Grant for Equity Lawyer Mr Ellis to represent the Sadhana Chaudhari Probate Estate
5. Sunaina Chaudhari Death Inquest Reopening
6. Kidnap Finding + Immediate Repatriation + Maternal Custody for the 2 Youngest Theodorou Children
7. Financial Credibility Fraud Case Reference to the Financial Service Authority and Metropolitan Police
8. .... whatever else Parliament needs for Remedy Credibility Recovery
