Grounds: Fraudulent Breach of Natural Justice + Human Rights + Overriding Justice Objective

Representations

The Pharmaceutical Industry bought Market Frauds for Drug Treatment against Other Treatment. They bought creation of the General Osteopathic Council to manage Market Frauds for Other Health Professions against the Osteopath Profession. Statute Frauds got Consolidated Jurisdiction Frauds to legislate, investigate, prosecute, adjudicate and execute. They used Before Trial Execution Frauds, Trial Denial Frauds and Trial Frauds for Ruin Frauds against the Victims. In 2000, Fraud Complaints in more than 200 Parliamentary Constituencies got an Osteopath Profession Governance Corruption Debate, Investigation Commitment by the Cabinet and Pending Investigation Adjournment. A Protection Fraud Deal got Investigation and Remedy Denial Frauds for the Pharmaceutical Industry in exchange for 2001 General Election Campaign Finance for Prime Minister Mr Blair. The General Osteopathic Council relied on Protection Frauds from Parliament to continue the Profession Governance frauds. It made the General Osteopathic Council a Corruption Remedy Obvious Target if there was revived use of the Coronation Oath Enforcement Authority. It needed Criminal Conspiracy Proof against a serving Prime Minister. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. Equity Lawyer Mr Edward Ellis used it for a Corruption Notice to the Crown and Parliament. It got revived use of the Coronation Oath Enforcement Authority and a Corruption Remedy Process that has continued ever since. In 2021 a Market Fraud Complaint by Citizen Ms Davies got a Smoking Gun Proof Set of Corruption Proof against the Profession Authority and Protection Fraud Proof against the State, General Medical Council, Cabinet and Parliament.
