Disclosure Application Refusal Reconsideration Notice + Fraud Appeal Intent Notice dated 17th October 2022. Child Passport Information Disclosure Application Refusal Reconsideration Notice + Fraud Appeal Intent Notice + Appeal Form Request by the Father to the Mother, State and Law Courts for the Stated Reason that:

- Child Passport Consent Demand by the Mother got a Relevant Evidence Disclosure Request by the Father and Repeat Disclosure Failures by the Mother, State and Northern Ireland Family Court that prevent an Informed Decision by the Father.
- A Northern Ireland Appeal Form Internet Search returned a number of web sites. None that provided a Family
 Case Appeal Form. One disclosed that a Reconsideration Request was an Appeal Condition. The Repeat
 Proposals dated 28th September 2022 were a Disclosure Failure Reconsideration Request.
- 3. In 2004 preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. Equity Lawyer Mr Ellis used it for a Corruption Notice to the crown and parliament. It revived used of the Coronation Oath Enforcement Authority and started a Corruption Remedy Process that has continued ever since. Equity Lawyer Mr Ellis provided Investigation Services. He recruited Citizens, managed cases and got Proof Sets that met the Corruption Remedy Proof Standard. In June 2016, the Father, Mr Patrick Coyle, got Citizen Status, acted as Northern Ireland Recruiting Agent for the Citizens, and helped manage Integrity Tests that got Corruption proof against the Northern Ireland Authorities.
- 4. The Coronation Oath Enforcement Authority used Parliament Session Powers to get Set-Up Conditions for Corruption Dismissals against Law Court Judges and Special Measures Decisions against the State, Profession Authorities and Law Courts. The Set-Up Conditions are:
 - 4.1. Fundamental Law Precedents set by Top Judges: Validity Priority [2008 HL R v Clarke] + Fraudulent Invalidity [Sharland v Sharland] + Justice Office Conflict Disqualification [Emerald Supplies v British Airways]
 - 4.2. Contempt Fraud Proof against Parties, Representatives, State Officers and Court Officers
 - 4.3. Contempt Immunity Fraud Proof against the State, Profession Authorities and Law Courts.
 - 4.4. Hearing Audio Records that are Personal Responsibility Proof against Identifiable Individuals as Party Representatives and Hearing Judges for Known Court Frauds to counter Protection Frauds got by Identity Record Frauds and Case Misrepresentation Record Frauds of the Law Courts
 - 4.5. Hearing Audio Records in the Office Tenure Period of the Prime Minister to eliminate Intimidation Fraud Defences by Law Court Judges that Order Frauds by Previous Cabinets got the Court Frauds
 - 4.6. Hearing Audio Records Denial Frauds Proof against Identifiable Supervision Judges of the Jaw Courts

Jurisdiction Reasons and Bias Fraud Reasons in the Proposals dated 5th September 2022 Operation Clean Sweep Reasons

Operation Clean Sweep is for a Power Transfer from the Protection Fraud Network to a Remedy Majority in Parliament. Scandal Exposure of an Election Fraud Conspiracy by the Cabinet, Opposition Leader Sir Keir Starmer and Market Fraud Profiteers forces MPs who want, or need, Repeat Candidacy to get Personal Credibility Proof. It needs them to get Remedy Co-operation Proof in the Parliament Session and Corruption Remedy Commitments in the General Election that validate a Remedy Mandate Claim and use of it, if necessary, to form a Remedy Majority Coalition. It needs Fitness Investigations by Candidate Selection Committees to identify and eliminate anyone who is a Corruption Exposure Risk. It needs Full Disclosure by All MPs in All Parties who by act or omission procured the 9 Months Dismissal Delay of the Dismissal Execution against Prime Minister Mr Johnson.

The Corruption Proof that got Protection Fraud Dismissals of Prime Minister Mrs May and Mr Johnson, and the Election Fraud Proof that got office for Prime Minister Mrs Truss, make it very likely that Conservative MPs will need a Coalition Majority.

Between 2010 and 2015 the Corruption Remedy Process managed by the Coronation Oath Enforcement Authority got Remedy Co-operation from Prime Minister Mr Cameron, Deputy Prime Minister Mr Clegg and Opposition Leader Mr Miliband. In 2022 the Labour Party has a Credibility Recovery Advantage conditional upon a Leadership Transfer to MP Mr Miliband or anyone else who has the Personal Credibility for Corruption Remedies that need Dismissal Executions against Law Court Judges.

Negotiation Offer from Equity Lawyer Mr Ellis to Opposition Leader Sir Keir Starmer for Immunity Terms in exchange for a Public Apology, Voluntary Resignation and Full Disclosure what got the offices of Director of Public Prosecutions and Labour Party Leadership, and use of them for Protection Frauds.
