

Before Judge

Upon reading the Various Orders dated 17th December 2021 of Judge Letham, the Bailiff Appointment Notice dated 25th October 2022, Emergency Stay Order dated 22nd November 2022 of High Court Justice Mr Knowles and the Eviction Stay and Contempt Remedy Application Notice and Draft Order dated 23rd November 2022

1. Interim Eviction Enforcement Stay Order + Eviction Warrant and Bailiff Appointment Verification Order for the Father Mr Sood against the Son Mr Sood for the reasons that
 - 1.1. Trust Asset Sale Orders by the County Court got Repeat Order Breach Contempt Proof against the Son and Bank of Scotland.
 - 1.2. In January 2020 the Father discovered the Coronation Oath Enforcement Authority. He gave them use his cases for Integrity Tests of the Authorities. One of the Integrity Tests was the Order Breach Contempt Remedy Application of the Father that got a Directions + Adjournment Order on 17th December 2021 by Judge Letham. The Father complied with the directions and awaits the Adjourned Hearing Date. The Other Orders of Judge Letham are subject to Court of Appeal Case 2022 001411. It awaits a Hearing Date.
 - 1.3. The Son claims to have Warrant 1A381003 and the Bailiff 2 Appointment Notice dated 25th October 2022 that is NOT SIGNED. He did not serve it on the Father. He sent a Next Day Eviction Notice Text to the Youngest Son, Mr Aman, Sood. At about 19.00 on Monday 21st November 2022 a Next Day Eviction Warning from the Youngest Son got Total Disbelief and a Proof Demand by the Father. The Youngest Son got an Email Attachment from the Trustee Son that purports to be a Bailiff Appointment Notice dated 22nd October 2022. A Criminal Complaint at 09.00 on 22nd November 2022 by the Father to the Metropolitan Police got CAD 1546 221122. Malicious Case Management by the Trustee Son caused the Father the Personal Injury of Anxiety Attacks, Chest Pains and Breathless Episodes. The Father believes the Ambush Eviction was an Attempted Murder. On 22nd November 2022 the Father asked a Lay Friend for help. She prepared a Handwritten Emergency Application to the High Court for a Case Transfer to the Criminal Court. It got the Interim Stay Order by High Court Justice Mr Knowles.
 - 1.4. Serial Trust Frauds and Repeat Order Breach Contempt Frauds by the Son got Contempt Immunity Proof against the Law Courts. The Integrity Test caused a series of Confidence Collapses and Record Falsification and Record Destruction by State Officers and Court Officers. The circumstances validate an Enforcement Stay and Records Audit starting with everything that got the Alleged Warrant 1A381003 and Alleged Appointment Notice with Bailiff 2.
2. Contempt Investigation Order + Discovery Order for the Father Mr Sham Sood that the Trustee Son Mr Vishal Sood do within 7 days file and serve a Statement that explains what he has to say in response to the allegation that Repeat Purchase Offers by the Youngest Son, Mr Aman Sood, as Purchasing Agent for the Father, got Sale Refusals by the Trustee Son Mr Vishal Sood that were Sale Order Breach Contempt, and if so why the Court should not make a Contempt Liability Order + Contempt Remedy Orders to include Personal Injury Damages for the Father against the Trustee Son
3. Discovery Order that the Chief Administrative Office of the County Court at Romford and Central London do within 7 days serve on the Claimant and the Defendant a copy of the Court Record and thereafter make Appointment Fixtures at each of the County Court Offices for Records Verification by the Parties and Court Officers
4. Costs Reserved + Contempt Directions 1 Hour Hearing at 2 p.m. on December 2022
