The Father was born in late 1952 to a poor family in India. He had little education. In 1976 he spoke no English came to the for an arranged marriage. He learnt basic English, got employment, made a success of the marriage and had 4 children. Medical negligence caused the death of his wife. He cared for the children. He used the Negligence Damages to found Family Trusts. He did not have the skill set needed for trust management. He appointed the 2 Older Sons as Estate Trustees. Both of them committed Trust Frauds against him. Both of them were, and are, Financial Service Agents. Both of them committed Court Frauds and got Immunity Frauds from the Law Courts.

The Coronation Oath Enforcement Authority is the Profession Authority for Top Judges and Top Politicians. They have Parliament Session Powers.

Corruption Investigations start with Original Frauds and work their way to the Money Laundering and Immunity Frauds, or the other way round.

The Coronation Oath Enforcement Authority discovered that the Protection Fraud Network used the Ministry of Justice to manage Crime Businesses. They needed Immunity Fraud Proof to service Corruption Investigations to the Original Crimes. The Father gave a Privilege Waiver, Confidentiality Waiver and Case Use Authority for Integrity Tests of the Authorities.

The Case Management of the 2nd Son was calculated to subject the Father to Chronic Stress. He obtained a Possession Warrant for 7 Hoveton Way and a Bailiff Eviction Appointment Notice dated 25th October 2022 for 23rd November 2022. He did not serve it on the Father. On Monday 21st November 2022 the 2nd Son sent an Eviction Notice Text to the 3rd Son. An Oral Eviction Notice by the 3rd Son got an Eviction Evidence Request by the Father that got the Appointment Notice attached to an email from the 2nd Son to the 3rd Son. Events revealed that the 2nd Son has intended an Ambush Eviction of the Father, The Only Credible Explanation is to get a Stress Death.

Competent Investigation will need to discover whether Perjury or Forgery got the Alleged Eviction Warrant and the Alleged Bailiff Appointment Notice. Evidence Offer of all of the Case Papers.
