

KB 2022 002098 Preliminary Hearing Fraud Conspiracy Appeal against the Claim Advocate and Adjudicator Conflict Disqualification Recusal Refusal Frauds, Conflict Jurisdiction Qualification Frauds, Jurisdiction Trial Denial Fraud + Liability Defence Sabotage Fraud + Civil Enforcement Penalty Permission Fraud on 23<sup>rd</sup> and 28<sup>th</sup> November 2022 of Cabinet Counsel Mr Eardley and High Court Justice Mr Soole  
Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

#### Remedy Proposals

1. 1<sup>st</sup> Claimant Status Order for Equity Lawyer Mr Ellis against the Solicitor General for the Party State Reasons that use of Claimant Status for the Agent instead of the Principal raises a Contempt Fraud Presumption that the true intent is Party Equality Avoidance, Accountability Avoidance and Liability Avoidance. It is subject to Rebuttal Proof. It requires Party Status for the Principal and a Contempt Purging by both the Principal and Agent.
2. 2<sup>nd</sup> Claimant Party Status Order for the Equity Lawyer Mr Ellis against the Cabinet for the Party Status Reasons
3. Corruption Case Finding + Pending Remedies Superior Jurisdiction Protection Rights Finding + Protection Breach Finding + Corruption Case Priority Entitlement Finding + Corruption Case Priority Denial Finding + Conflict Disqualification Finding + Remedy Only Jurisdiction Limit Finding + Conflict Disqualification Recusal Refusal Finding + Recusal Reasons Denial Fraud + Cabinet Counsel Conflict Qualification Pretence Fraud Finding + Adjudicator Conflict Qualification Pretence Finding + Remedy Only Jurisdiction Limit Breach Finding + Jurisdiction Trial Denial Frauds, Defence Sabotage Fraud Finding, Admissibility and Relevance and Credibility and Interpretation and Probity Frauds Finding, False Evidence Admission Frauds Finding, Innocence Evidence Exclusion Fraud Finding, Silence Rights Advice Fraud Finding, Witness protection Denial Fraud, Civil Contempt Penalty Enforcement Permission Fraud Finding, Witness Protection Denial Fraud Finding and Appeal Leave Denial Fraud Finding + Conspiracy Finding + Contempt Liability Finding + Remedy Entitlement Finding + Personal Injury Torture Damage Finding + Remedy Priority Finding for Equity Lawyer Mr Ellis against Cabinet Counsel Mr Aidan Eardley, all of the Law Courts of all ranks in all courts who have serviced the processes that got, and exploited, the Law Practice Disqualifications Frauds and General Civil Restraint Frauds against the Equity Lawyer the Stated Reason that the Conflict Qualification Frauds get a Fraud Presumption for the Equity Lawyer, as Fraud Victim, against Cabinet Counsel Mr Eardley and the Judges as both Fraud Managers and Fraud Beneficiaries, subject to Rebuttal Proof, that in the circumstances is impossible by any Proof Standard
4. Contempt Purging Order + Order Breach Contempt Liability and Remedy Penalty Warning for the Equity Lawyer that the Solicitor General and Attorney General do both within 7 days file and serve Statements explaining why the Court should not make a Joint Liability Order against the Cabinet as Principal and the Solicitor General as Agent for the General Civil Restraint Frauds committed by Cabinet Counsel Mr Eardley and the Judiciary
5. Contempt Directions 1 Hour Hearing in Royal Court at 2 p.m. December 2022
