

1. The Equity Lawyer will file and serve the Fraud Appeal against the 2022 003098 Penalty Enforcement Permission and Trial Directions dated 28<sup>th</sup> November 2022 when he receives the Sealed Order. He is not well enough to produce DETAILED Appeal Grounds. The BRIEF Appeal Grounds enable progress.
2. The King can use the BRIEF Appeal Grounds and Defence Bundle of 145 pages to make the Trial Order and Evidence Production Order for a Corruption Case against the State and Unfitness Cases against the Law Courts. It will enable Trial Findings before the end of the Christmas Term
3. Prime Minister Mr Sunak can call a Full Cabinet Meeting, uses the BRIEF Grounds and Trial Order for a Remedy Co-operation Motion Proposal, reminds the Cabinet Officers that in Corruption Remedy Cases they have the Credible Neutrality Obligation of Justice Officers. It needs Voluntary Disclosure of Conflicted Interests and the Disqualification Remedy of withdrawal from the Decision Process. He asks if anyone wishes to contest the Remedy Co-operation Proposal. In the event of No Contest, the record be ‘No Contest + Motion Carried Unanimously’
4. The Equity Lawyer will try to produce DETAILED Grounds in time for the Jury Trial. No Promise.
5. The Lord Bishop Trial Jurors decide Remedy Priorities that include:
  - 5.1. Mass Publicity for the Coronation Oath Enforcement Authority and Corruption Remedy Process
  - 5.2. Mass Publicity for Contempt Claims + Case Re-opening + Intervention Applications by the Attorney General to deliver Immediate Remedies for the Citizens whose cases serviced the Corruption Remedy Process
