GROUND: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

PROPOSALS

1. Eviction Enforcement Interim Stay pending Credibly Independent Adjudication of the Corruption Claim 2022 100826 against the UK Cabinet and Northern Ireland Authorities and Bankruptcy Trustee for Citizen Mr Barr against Bankruptcy Trustee Mr Thomas Keenan for the Stated Reason that the Corruption Remedy Process of the Coronation Oath Enforcement Authority needs it
2. Contempt Investigation Order + Discovery Order + Order Breach Contempt Penalty Warning for Citizen Mr Barr that the Bankruptcy Trustee Mr Thomas Keenan do within 7 days file and serve the Helen Barr Probate Estate Administration Grant to Lawyer Graham Keys and the Grant Revocation and the Probate Estate Administration Grant to Bankruptcy Trustee Mr Thomas Keenan
3. Contempt Directions 1 Hour Hearing in the High Court at 2 p.m. on 2023

THE SCHEDULE

The Eviction Stay Application dated 5th December 2022 appears in italics below

Corruption Investigations can start at the beginning and work forward, in the middle and work backwards and forwards, or start with the Money Laundering and Contempt Immunity Frauds by Law Court Judges and work backwards. The Corruption Remedy Process of the Coronation Oath Enforcement Authority uses Integrity Tests of Authorities for Corruption Investigations. The Remedy Process needs Corruption Proof against the Northern Ireland Authorities and English Authorities for Co-ordinated Remedy Management. The Coalition Failure by the Northern Ireland Assembly got Governance Failure Joint Liability for the UK Cabinet and Parliament.

The Corruption Summons of Citizen Mr Barr against the UK Cabinet and Northern Ireland Authorities explains the Case Frauds. They did not get Settlement Negotiations or an Eviction Stay. Integrity Tests got Similar Fact Trust Fraud Proof against the English Law Courts. The most recent was Contempt Signature of Citizen Mr Barr

Immunity Fraud Proof against the High Court on 22nd and 23rd November, against the County Court on 25th November and against the High Court on 28th November 2022.

Corruption Remedies and Economic Growth under Full Employment Conditions need revival of Common Law Accountability Powers for the Citizen against the State. It needs Advanced Electronic Signatures for an Authority Management System. The Remedy Options include using the small population and small Lawyer Replacement Requirement of Northern Ireland for System Trialling. Recruitment will be on Corruption Remedy Conditions that require Full Disclosure about All Known Frauds. The small population makes it likely that the Credible Neutrality Obligation of Representatives and Judges cannot be met without Replacement Lawyers from the remainder of the UK. Replacement Lawyers from Northern Ireland that get Integrity Proof will have Marketable Skills in the rest of the UK and in all other Sovereign States that decide they need Advanced Electronic Signatures.

The Order dated 7th December 2022 of Master Kelly appears in italics below

UPON THE COURT BEING SATISFIED THAT no valid application has been brought by the Bankrupt pursuant to the provisions of the Insolvency (Northern Ireland) Order 1989 ("the 1989 Order"), THE COURT OF ITS OWN MOTION, and pursuant to its powers under Article 334 (1) of the 1989 Order, ORDERS:- 1. That enforcement of the order for possession of property situate and known as 10 Chippendale Gardens, Belfast, Co Antrim, BT10 0DX which said order was made by this Court on 29th July 2022 is hereby stayed to 25.01.23 at 10.30am whereupon the Court shall review its order administratively; and 2. That, if by 10.30am on 25.01.23 a properly constituted application is not brought pursuant to the provisions of the 1989 Order, and in the prescribed form, the above stay of enforcement shall be rescinded pursuant to Article 371 of the said Order
