Stated Reasons

The 2022 Parliament Session Priority is Remedy Delivery. It used Corruption Remedy Special Measures against the State, Profession Authorities and Law Courts. It got Dismissal Executions against Sex Predators and Idiot Bullies and Protection Frauds for Framing Fraud Managers and Crime Business Managers. Northern Ireland has a population of 1,500,000. It is small enough for Replacement Judiciary Testing. The Remedy Process needed Similar Fact Fraud Cases that are Crime Business Management Proof against the Ministry of Justice, Law Courts and Judiciary in England and Northern Ireland. The Probate + Bankruptcy Frauds against Citizen Mr Barr are Crime Business management Proof against the Northern Ireland Authorities. At all material times Citizen Mr Barr has been Severely Disabled and had Management Incapacity for Corruption Cases. On the evidence available a Probate Contest Fraud by his Sister drew attention to his Home Ownership and Family Inheritance. Influence Frauds got Probate Contest Legal Service Denial Frauds. Then Benefit Termination Frauds were Domestic Rate Relief Disqualification Frauds that got a Rate Liability Declaration Fraud and Bankruptcy Fraud and Crime Framing Frauds and Home Dispossession Fraud and Inheritance Dispossession Fraud. Northern Ireland Coalition Governance Failures got Direct Governance by the UK Cabinet. The Corruption Claim 2022 100826 of Citizen Mr Barr gave Defendant Status to the UK Cabinet and Northern Ireland Authorities. The Bankruptcy Fraud Case Pending Adjudication Eviction Stay Application got Conflict Qualification Fraud Proof and Case Allocation Fraud Proof and Administrative Decision Classification Fraud Proof and a Court Motion Order Fraud Proof against High Court Master Kelly. The Adjourned Hearing on 26th January 2023 will get an Audio Record that is Personal Responsibility Proof.
