1. All Cases Interim Remedy Enforcement Stay Protection Pending Adjudication by the Superior Jurisdiction of the High Court for Citizen Mr Akwasi Nkrumah against the Inferior Jurisdictions of the State, Profession Authorities and Magistrates Court, Crown Court, County Court, Attorney General and Cabinet for the Stated Reasons that the Claim Brief Explanation needs Pending Adjudication Interim remedies
2. Contempt Directions 1 Hour Hearing in Royal Court at 2p.m. on January 2023
Claim Brief Explanation
 1. The Justice Priority needs Interim Remedies pending
 2. The Citizen gave use of his cases to the Coronation Oath Enforcement Authority for Integrity Test. They got Corruption Proof against the State and Remedy Denial Proof against the Law Courts and Protection Fraud Proof against the Cabinet, Governing Majority and Opposition Minority.
 3. The Coronation Oath Enforcement Authority used it to decide the 2021 Parliament Session Corruption Remedy Priorities. They are Corruption Remedy Special Measures against the State, Profession Authorities and Law Courts. Priority.
 4. Special Measures got Dismissal Executions against Sex Predators and Idiot Bullies and Protection Frauds for Framing Fraud Managers and Crime Business Managers.
 5. A Protection Fraud Call by Essex Crown Court Judges got an Assault Framing Fraud Ambush by British Rail Police and Essex Police at Basildon Railway Station.
 6. The Event Videos were Innocence Evidence for the Citizen and Perjury Conspiracy Proof against the Witnesses, Investigators, Prosecutors. The Basildon Assault Trial 2100279461 Evidence Production Orders by the Magistrates Court got Repeated Order Breach Contempt Proof against the Investigators and Prosecutors and Contempt Immunity Fraud Proof against the Magistrates Court. Case Stated Applications to the Magistrates Court and Crown Court for Jurisdiction Fraud Appeals to the High Court in All Cases got Process Denial Fraud Conspiracy Contempt Proof against the Magistrates Court and Crown Court
 7. On 7th December 2022 the Basildon Assault Trial got completion of the Contempt Immunity Fraud Proof a Conviction Fraud and a Sentence Hearing Order for 13th January 2023. The details are in the Basildon Assault Trial 2100279461 Fraud Appeal Case Stated Application. A Conviction and Sentence Fraud Appeal will get Audio Records of the Trial fraud Findings by Crown Court Judges or Trial Fraud Enforcement Proof against them. A Telephone Call got Oral Notice from a Court Officer to the Citizen that on 13th January 2023 there will be a Repeat Trial and not a Sentence Hearing. Probation Report Production Requests get Production Failures by the Probation Officer. It raises Reasonable Suspicions of either Probation Report Frauds + Late Production Ambush or that Crown Court Judges need to stop the Conviction + Sentence Fraud Appeal getting the Audio Records. The Contempt Claim and Pending Adjudication Enforcement Stay Protection Application is a Special Measures Integrity Test of the High Court.
