On 23rd and 28th November 2023 the 2022 0030989 Preliminary Hearing got Defence Application Hearing Denial Fraud Proof against Justice Mr Soole for the Given Reason that the 2022 002595 General Civil Restraint Renewal vested Defence Case Management Powers in Justice Mr Eyre. The 2022 003098 Approved Judgment and Sealed Order Service Delay prevented the 2022 002595 Test until 16th December 2023.

On 16th and 19th December 2022, the 2022 002595 Trial Preparation Defence Applications got Hearing Denial Fraud Conspiracy Proof against the Fee Manager and the Listing Manager.

On 19th December 2022 the filing of the Contempt Penalty Enforcement Fraud Appeal in the Court of Appeal Drop Box got Automatic Pending Adjudication Enforcement Stay Protection against the Cabinet and High Court and Case Reference 2022 002522, and 29-Day Notice Delay, until the Notice Email at 13.48 on 17th January 2023 of the Case Reference + Missing Signature in sections 11 and 13.
