The Nations need to know Northern Ireland Master Kelly had Effective Notice of the Corruption Remedy Process. Case Papers give it in Legal Language. The REPRESENTATIONS give it in Ordinary Language.

The UK is manging Governance Change from a Corrupt Culture to an Honest Culture. There have been Culture Change Successes in the past. The Ice Age caused Food Shortages that forced the Survival Strategy of Child Sacrifice. It was Standard Practice for Ancient Religions. The Hebrews, led by Abraham, managed the change from Child Sacrifice to Lamb Sacrifice. The Hebrews managed the adoption of a Law Standard that enabled 12 tribes to function as a nation. The Hebrew Rabbis managed a Culture Change in one of the two Hebrew Kingdoms but not the other. They used Coronation Refusals against Usurper Kings for Crown Succession Law Enforcement. It got Peaceful Successions for a period of 250 years. In the other kingdom in the same period every succession was a Military Coup. The Gnostic Christians managed Culture Changes. They managed the Power Transfer from Church Courts to Crown Courts and from the Judge to the Jury under Henry II. They united England and Wales under one Crown, disband the Marcher Lord Armies and got Corruption Remedy Powers by the Chancery for the Citizen against State Officers under Edward I. The recognition of the Chancery Court in 1307 is part of the evidence. They advised Edward III to respond to the Black Death Labour Shortages by creating the Magistrates Courts. It enabled County Squires to use Local Conditions to dismantle Feudal Service. The Gnostic Christians managed the process that persuaded James II to leave the jurisdiction, used it for an Abdication Finding against him and Lawful Success Finding for Mary conditional upon a Crown Powers Limit to service of the Coronation Oath Enforcement Authority. They responded to the Dictator Governance |Plan for the Equity Governance Recovery. It is in progress.

A Good Culture is hard to develop and maintain. The UK had a Good Culture. It was Equity Governance. It used the Common Law to service the Justice Priority of the People. It vested Parliament Session Powers in the Coronation Oath Enforcement Authority conditional upon use of the Corruption Remedy Proof Standard. It vested Investigation Powers in the Citizen, Prosecution Powers in the Crown and Adjudication Powers in the Lord Bishops. The Suez Scandal got a Confidence Collapse by the Cabinet of Prime Minister Mr MacMillan and a Dictator Governance Plan. The Citizen used cases for Integrity Tests of the Authorities. They got Justice Proof for Honourable Officers or Corruption Proof against the State and Remedy Denial Fraud Proof against the Law Courts. The Crown used fraud Proof for Trial Orders of Corruption Cases against the State and Unfitness Cases against Officers and Authorities. Corruption Proof got Corruption Findings, Remedy Entitlement Findings, a series of Remedy priority Findings to investigate who is Responsible, and Dismissal Decisions against law Court Judges with Execution Responsibility against the Cabinet. A Dismiss Success is Justice Proof for the Cabinet. A Dismissal Failure is Protection Fraud Proof against the Cabinet. It gets the Default Penalty of a Dismissal Decision against the Prime Minister. Dismissal Success is Justice Proof for who among the Governing Majority and Opposition minority who manage it. A Dismissal Failure is Protection Fraud Proof against the Governing Majority and Opposition Minority. The Ultimate Sanction is a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof, Remedy Denial Fraud Proof and Protection Fraud Proof. The Citizen Identity was the Dominant Identity because Corruption Remedies depended on the Citizen using Investigation Powers and getting Proof Sets that met the Corruption Remedy Proof Standard.

The Suez Scandal got a Confidence Collapse by the Cabinet of Prime Minister Mr MacMillan and a Dictator Governance Plan to substitute the Obedience Priority of the State for the Justice Priority of the People. It needed a transfer of Corruption Investigation Powers from the Citizen to the Cabinet. A Governance Referenda Demand by Queen Elizabeth II got a Referenda Refusal by the Cabinet. They knew Referenda Process would have been an Education Process that ended with the choice between Dictator Powers for the State and Accountability Powers for the Voter. They knew it would have got a Landslide Majority for Equity Governance against Dictator Governance. The Cabinet and Opposition made a Dictator Governance Fraud Plan. It used Sabotage Frauds against the Coronation Oath Enforcement Authority. It got a Bad Culture.

The Gnostic Christians made an Equity Governance Recovery Plan. It had two strategies. One was for the Citizen to develop Advanced Electronic Signature Technology, provided sophisticated services, enabled the Prosperous Classes to manage Tax Haven Estates from their homes, and use Taxation Starvation to force conversion from Dictator Governance to Equity Governance. The other was to get Criminal Conspiracy Proof against a serving Prime Minister and get revived use of the Coronation Oath Enforcement Authority. It needed the Crown to keep the Coronation Oath Enforcement Authority fit for use until Taxation Starvation or Criminal Conspiracy Proof against a serving Prime Minister got Revived Use.

The Politicians lost control of Dictator Powers to Crime Partnerships of State Officers and Law Court Judges. They developed a Protection Fraud Network to provide Support Services and Co-ordinated Corruption. They sold Market Frauds to Organised Crime, provided Protection Frauds for the Corrupt Officers who managed them, and traded Glittering Career Guarantees and Job Profits in exchange for Fraud Services by Corrupt Politicians. General Elections got Governing Majorities that were crippled by Remedy Denial Majorities controlled by the Protection Fraud Network.

The Devolved Governance deprived the Citizen of Corruption Control Powers the Devolved Authorities in Scotland, Wales and Northern Ireland. The Equity Governance Recovery Process needed Management Co-ordination of Corruption cases against Devolved Authorities and UK Authorities.

The Coalition Failure by the Northern Ireland Assembly Members got Direct Rule by the UK Cabinet. The Ruin Fraud Cases of Citizen Mr Barr were excellent for Co-ordinated Case Management. A Probate Fraud Signature of Citizen Mr Barr
