  - 5.1. The Probate Frauds, Benefit Frauds, Bankruptcy Frauds and Crime Framing Frauds got Crime Business Management Proof for Citizen Mr Barr and the Coronation Oath Enforcement Authority against the State and Law Courts in Northern Ireland. The Coalition Governance Failure by the Northern Ireland Assembly Members got Direct Government by the UK Cabinet. It enabled Co-ordinated Management of Corruption Remedy Test Cases in England and Northern Ireland.
  - 5.2. Dismissal Decisions against Law Court Judges got Protection Fraud Proof against the Cabinet. The Default Penalty was a Dismissal Decision against Prime Minister Mr Johnson. Dismissal Help Requests by Governing Majority Back Benchers got Help Refusals by Opposition Leader Sir Keir Starmer. In 2012 a Corruption Investigation got Protection Fraud Proof against him when he was Director of Public Prosecutions. The Opposition Leader and Cabinet made a

Protection fraud Concealment Plan for themselves and a Protection Fraud Exposure Plan against Law Court Judges. The Concealment Plan used Revenue Termination Blackmail by the Cabinet and Big Business to get Protection Fraud Concealment Propaganda Services from the BBC and Independent Media. Test Cases in the 2022 Local Elections and 1<sup>st</sup> 2022 Leadership Contest got Election Fraud Conspiracy Proof against the Media, Law Courts and Top Politicians.

- 5.3. The 2022 Parliament Session Priority is Corruption Remedy Special Measures of the People against the State, Profession Authorities and Law Courts. Test Cases got Dismissal Executions against Sex Predators and Idiot Bullies and Protection Frauds for Framing Fraud Managers and Crime Business Managers. It got Case Priority for Framing Fraud Cases against Other Cases. It needed Personal Responsibility Proof against Identifiable Individuals for Known Court Frauds. Case Process Denials are Personal Responsibility Proof against Supervision Judges. Hearing Audio Records are Personal Responsibility Proof against Hearing Judges. Top Judges used Process Frauds to avoid Hearing Denial Proof against themselves. They used Hearing Orders and Case Allocations as Sacrifice Decisions that got Audio Record Proof against Lower Rank Judges Frauds.
- 5.4. The Contempt Claim 2022 003098 and Contempt Penalty Enforcement Permission Application of the Cabinet against Equity Lawyer Mr Ellis got a Forced Hearing by High Court Justice Mr Soole. The Audio Record that is Conflict Qualification Fraud Proof and Trial Fraud Proof against Justice Mr Soole and Other High Court Justices. The Defence Applications got Hearing Refusals for the Given Reason that the 2022 002595 General Civil Restraint Renewal against the Equity Lawyer vested Defence Case Management Powers in High Court Justice Mr Eyre.
- 5.5. The Royal Commission + 2022 003098 Listing Emails Log from 14<sup>th</sup> December 2022 to 18<sup>th</sup> January 2023 evidences Case Management Co-ordination. The 2022 003098 Fraud Appeal got Case Reference 2022 002522 and a Notice Delay from the Court of Appeal until after the Theodorou Divorce ZC14D02308 Property Fraud Appeal got the Hearing Audio Record on 16<sup>th</sup> January 2023 that completes the Child Trafficking Fraud Conspiracy Proof against English Law Courts. The Defence Application Tests by the Equity Lawyer that got the Hearing Denial Fraud Proof and Trial Unreadiness Proof against the English High Court and the Date Notice for 8<sup>th</sup> March 2023.
- 5.6. The choice for Northern Ireland Master Kelly was to accept Personal Responsibility for the Known Court Frauds against Citizen Mr Barr, or force the Higher Rank Judges to accept it.
