Make oath and say as follows:

1. I have the Severe Physical Disabilities of Bowel Problems, Chest Problems and Spinal Damage from a Broken Coccyx. I have Case Management Capacity for Ordinary Cases but not Corruption Cases.
2. My parents married and had my sister and me. My father died.
3. My mother became ill. She made a will that gave equal shares to my sister and me. My mother helped me buy a Long Leasehold Flat on a Council Estate using the Tenancy Discount.
4. I was Primary Carer for my mother for years.
5. My sister and brother-in-law persuaded her to put £40,000 in an account in the joint names of my mother and my brother-in-law.
6. Something caused my mother to have doubts about it. She asked for some of the money and got it. She contacted the Family Lawyers with intent to change the will. Undue Influence Allegations by my sister got a Service Refusal by the Lawyer. My mother died.
7. The estate was very simple. It was the house, money and not much more. My sister did not want a simple division. She wanted Sole Control of the Probate Estate. She filed a Probate Contest Claim and made Undue Influence Allegations against me. Service Requests by me got Service Refusals by two Law Firms for the Stated Reason that she made Undue Influence Allegations. I do not know how she came to have the power to deny Legal Services to an Established Client, my mother, and a Case Opponent, me.
8. The Probate Contest brought the ownership of my flat and my half share of the Probate Estate to the attention of Corrupt Officers. They used a Benefits Termination Fraud to get a Council Tax Liability Framing Fraud and Council Tax Bankruptcy Enforcement Fraud for Home Theft and Inheritance Theft.
9. A friend told me about the Coronation Oath Enforcement Authority. I gave a Privilege Waiver, Confidentiality Waiver and Case Management Authority. It enabled use of the truth, whole truth and nothing but the truth for Integrity Tests of the Authorities. It got Corruption Proof against the State and Remedy Denial Fraud Proof against the Law Courts. The Coronation Oath Enforcement Authority used it for Corruption Findings and Dismissal Decisions against Law Court Judges. The Cabinet needs Co-ordinated Management of Corruption Cases in England and Northern Ireland. They needed cases that were big enough to pay for Protection Frauds by Law Court Judges, but not big enough, on their own, to pay for Protection Frauds from the Northern Ireland Assembly or UK Cabinet.
