Let all parties concerned attend before the Master at the Royal Courts of Justice, Chichester Street, Belfast at 10.30 am on the 25th day of January 2023 on the hearing of an application on the part of the Defendant for

1. Conflict Disqualification Admission + Conflict Jurisdiction Recusal + Remedy Only Jurisdiction Limit Admission by Master Kelly the Stated Reason that:
 - 1.1. The Coalition Failure by the Northern Ireland Assembly got Direct Rule by the UK Cabinet.
 - 1.2. The Corruption Remedy Process of the Coronation Oath Enforcement Authority needed Co-ordinated Management in England and Northern Ireland of Corruption Cases in which the UK Cabinet was a Party Principal and the amounts large enough to finance Protection Fraud Fees for Law Court Judges, but too small, on their own, to finance Protection Frauds from Northern Ireland Assembly Members or the UK Cabinet.
 - 1.3. The Probate Frauds + Benefit Termination Frauds + Council Tax Liability Frauds + Council Tax Bankruptcy Enforcement Frauds + Home Theft + Disinheritance Theft + Crime Framing Frauds committed against the Severely Disabled Mr Barr are excellent for that purpose in Northern Ireland
 - 1.4. The Corruption Claim 2022 100826 + Remedy Application of Citizen Mr Barr against the UK Cabinet, UK Ministry for Northern Ireland, Northern Ireland Authorities, Bankruptcy Trustee and Bankruptcy Trustee Lawyers got Remedy Denial Fraud Proof against the High Court Kings Bench Division when the C012388391 + 21 045650 Eviction Stay Application got it against the Chancery Division. Correct Form Request by the Citizen got Request Refusals by Chancery Counter Officers. On 23rd January 2023 Papers Filing by Citizen Mr Barr got a Filing Refusal by the Chancery Division Counter Officer and a Filing Refusal of the 21 045650 Papers by the Kings Bench Counter Officer for a Closed Case Reason, until he was told of the Adjourned Hearing on 25 January 2023 got Receipt Stamp Filing Proof. It gave a Chancery Officer the confidence to provide a Blank Summons Form for compliance with the C012388391 + 21 045650 dated 7th December 2022.
2. An Eviction Enforcement Stay Pending Adjudication of the Corruption Claim 2022 100826 of Citizen Mr Barr against the UK Cabinet and Northern Ireland Authorities and Bankruptcy Trustee and Bankruptcy Trustee Lawyers.
3. An Eviction Enforcement Stay Pending Adjudication by High Court Justices of the Appeal against the Conflict Qualification Fraud + Bankruptcy Frauds + Eviction Stay Application Allocation Fraud by the Supervising Judges of the High Court and Chancery Division that got the Conflict Qualification Fraud + Invalid Application Finding + Court Motion Order dated 7th December 2022 of Master Kelly that read:

UPON THE COURT BEING SATISFIED that no valid application has been brought by the Bankrupt pursuant to the provisions of the Insolvency (Northern Ireland) 1989 "the 1989 Order"
THE COURT OF ITS OWN MOTION, and pursuant to its powers under Article 334 (1) of the 1989 Order, ORDERS
1 The enforcement of the order for possession of the property situate and known as 10 Chippendale Gardens, Belfast, Co Antrim, BT10 0DX which said order was made by this court on 29th July 2022 is hereby stayed to 25.01.23 at 10.30 am whereupon the Court shall review its order administratively; and
2 That if by 10.30 am on 25.01.23 a properly constituted application is not brought pursuant to the provisions of the 1989 Order, and in the Prescribed Form, the above stay of enforcement shall be rescinded pursuant to Article 371 of the said Order
4. An Eviction Enforcement Stay Pending Adjudication of the Prescribed Form Identification Application dated 29th December 2022 with Filing Date 5th January 2023 needed to comply with the part of the Order dated 7th December 2022 of Master Kelly
