A message from Just Eat to Mr Bayram Yediayli reads 'Hello, I strongly urge you to call justeat from this number 020 3912 6571, as it will take you directly to the restaurant team who is dealing with this issue.'

Mr Yediayli is a Corruption Victim. He has been cooperating with a Corruption Investigation.

The Citizen Crown and Lord Bishops have Justice Responsibilities known as the Equity Monarchy Trusts. They have Corruption Control Jurisdictions that govern Parliament Session Powers. Since 2004 they have managed a Corruption Remedy Process. Equity Lawyer Mr Ellis has provided Investigation Services. He provides Legal Services that enable Corruption Victims to get Criminal Conspiracy Proof against State Officers and Law Court Judge

Organised Criminals, State Officers and Law Court Judges formed Business Theft Partnerships. State Officers use Framing Frauds against Business Owners to get Forced Sales and Business Thefts. The 1st Framing Fraud against Mr Yediayli failed. It used Immunity Frauds to get Harassment Perjury from 3 Women Witnesses. The Crown Court Judge noticed Innocence Evidence Concealment Frauds, supervised the Jury into an Acquittal Decision and gave Claim Advice for the Victim against the Metropolitan Police, Ministry of Justice and Defence Lawyers. Corruption Investigators waited to see what happened. Emotional Exhaustion, Financial Exhaustion and Limited English Language prevented Mr Yediayli acting on the Claim Advice. The 2nd Framing Fraud used Planted Evidence and Hygiene Regulation Breach Finding Frauds for a Forced Business Closure and Conviction Fraud. They got a Forced Sale and Business Theft. The Shop Theft Complaint got Investigation Denial Fraud Proof against the Metropolitan Police. The Shop Theft Claims QB 2019 003741 + 003984 in the High Court got a 1st Backdated Order Forgery that was Criminal Conspiracy against Top Judges. They made a Protection Fraud Call to the Metropolitan Police for Investigation Frauds and Finding Frauds against Mr Yediayli that they could use for Claim Dismissal Frauds. Mr Yediayli, his Interpreter and Equity Lawyer Mr Ellis attended the Complaint Interview. They produced the Criminal Conspiracy Proof against the Top Judges. It got a No Further Action Case Closure Fraud against Mr Yediayli but did not get Finding Frauds against him. Mr Yediayli called the Metropolitan Police. They ignored the Ownership Proof of the Registered Title and the Court Papers and committed a Repossession Fraud for the Organized Crime Buyer. The Equity Lawyer used the Repossession Fraud Proof for a Contempt Fraud Remedy Application in the High Court. It got Remedy Denial Fraud Proof that added to the Criminal Conspiracy Proof against the Top Judges.

Other cases got Similar Fact Proof against Top Judges of Property Thefts. The Lease Fraud F02ED793 got Lease Forfeiture Fraud Conspiracy Proof against an Organised Crime Landlord and County Court Judges. They used an Adjournment Fraud to avoid an Audio Record of the Appeal Judge receiving the Criminal Conspiracy Proof. Fraud Appeals in the Court of Appeal will force Lord Justices to process the Criminal Conspiracy Proof against them.

Just Eat has Business Records relating to Barry's Fish Bar. They are Relevant Evidence for the Corruption Investigation.

On 10th February 2021 the 2019 004208 Liability Trial got Self Representation Incapacity Proof for

Citizen Defendant Ms Berry. The State Representatives and Trial Judges ignored it. The Incapacity Remedy Failures by the State Representatives and Trial Judges create Conflict Disqualification and Remedy Only Jurisdiction Limit for the Citizen against the Attorney General and the Trial Judges.
