The Coronation Oath Enforcement Authority decides the Corruption Remedies Priorities for Parliament Sessions. The 2022 Session Priority is Corruption Remedy Special Measures against the State, Profession Authorities and Law Courts. Test Cases got Dismissal Executions against Sex Predators and Idiot Bullies and Protection Frauds for Liability Fraud Managers and Crime Business Managers.

The Northern Ireland Peace Settlement was a Power Transfer to Organised Crime. It got the Unfinished Business of a Power Transfer from Organised Crime to Equity Governors.

The European Constitution vested Dictator Powers in the State. European Leaders wanted Referenda Acceptance of the Dictator Powers. The committed Election Frauds to get it. In 2005 it got Referenda Acceptance in Spain and Referenda Rejections in France and The Netherlands. In 2008 more Election Frauds got Referenda Rejection in Eire. In 2009 more Election Frauds got Repeat Referenda an Acceptance Majority. The Election Frauds were Unfinished Business.

Fraud Concealment was a Shared Priority of European Leaders and Prime Minister Mrs May, Mr Johnson and Ms Truss, but not of Prime Minister Mr Sunak. It enabled him to get the Windsor Agreement.

The Cabinet needed a Test Case in Northern Ireland that had enough, on its own, to get Fraud Services by State Officers and Law Court Judges but not enough for Assembly Members or Cabinet Members. The Ruin Fraud against Citizen Mr Barr are excellent for the purpose. His mother died. A Probate Fraud by his sister drew the attention of Law Court Judges to his Flat Ownership and Half Share Inheritance. They used a Benefits Termination Appeal to get a Property Tax Liability and a Bankruptcy Enforcement Fraud.

The Test Case will service Corruption Remedy Special Measures against the Northern Ireland Authorities and the Unfinished Business. Case Papers explain the process.
