Thank you for everything so far. Allergy Test Negative Results enable Transplant Progress.

Test Cases got Dismissal Executions against Sex Predators and Idiot Bullies, and Protection Frauds for Framing Fraud Managers and Crime Business Managers. Record Frauds created a need for Audio Records that are Personal Responsibility Proof against Identifiable Judges for Known Court Frauds. Top Judges used Hearing Denials to avoid Audio Record Proof against them. They used Hearing Orders and Case Allocations that got Audio Record Proof against Lower Rank Judges. The Cabinet needed Forced Hearings and Audio Records that are Trial Fraud Conspiracy Proof against High Court Justices. They used Claim 2022 003098 to get it. 3 Fraud Appeals got Trial Fraud Conspiracy Proof against the Court of Appeal. All of it got fraud Appeals to the Supreme Court. It traps top Judges.

Crisis Conditions got a Forced Resignation from Prime Minister Ms Truss, and a Leadership Contest. The Leadership Deals got the Premier Office for MP Mr Sunak and kept Cabinet Office for Puppet Representatives of the Protection Fraud Network. He needed to do something to assert his authority. He told European Leaders that Corruption Findings and Dismissal Executions against Law Court Judges in the UK will expose Mass Corruption in the European Union. It got the Windsor Agreement. We did not get it in the previous 6 years and 9 months because the Shared Priority of European Leaders and Prime Ministers Mrs May and Mr Johnson was Corruption Concealment. It enabled European Leaders to manage Union Sabotage Frauds against the UK. The Brexit Deal was one of them. It got a Forced Resignation from Scottish Leader Ms Sturgeon. The Scottish National Party keep her and face Voters who knew Corruption Remedies were imminent or in progress.
