Special Service Request + Full Disclosure Authority + Circulation Request Remedy Belief is a Precious Resource. The People need it. Good Will Religion Leaders have it. They must not be over-burdened.

Remedy Disbelief is Corruption Damage done by the Governance Plan for Western Europe. Politicians vested Dictator Powers in the State and lost control to Organised Crime. It got Endemic Corruption and Remedy Disbelief. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders. The Coronation Oath Enforcement Authority used it to start a Corruption Remedy Process that has continued ever since.

Some of the European Leaders supported the Remedy Process. Most resisted it until early 2023. Prime Minister Mr Sunak gave notice that the Remedy Process will get Dismissal Executions against Law Court Judges. They abandoned the Union Sabotage Plan against the United Kingdom, made the Windsor Agreement and prepared to vest Corruption Control Powers in the Citizen.

The UK People and European Leaders need the Remedy Success on an Industrial Scale. The Qualified Professions cannot provide it. Endemic Corruption used Disqualification Frauds against Remedy Professionals and Career Benefit Frauds for Corrupt Professionals. The vast majority of Qualified Professionals in Active Service have Corruption Contamination. Mass Remedies needs Audio Records that are Personal Responsibility Proof against Identifiable Individuals for Known Court Frauds. Trial Denial Frauds by Civil Courts created a disproportionate dependency on Criminal Trial Frauds for Audio Records that are Criminal Conspiracy Proof against Prosecutors, Defenders and Judges. A Confidence Collapse has created an Acute Shortage of Criminal Advocates. The Public Reason is Low Pay. The Private Reason is Corruption Accountability.

Case Management Success needs Remedy Belief, Emotional Independence and Objective Judgment. Few Victims have all of it. In many cases Chronic Immature or Chronic Stress Damage creates a need for Emotional Support. All Cases need Objective Judgment.

The Special Service needs the recovery of Remedy Belief by Victims and then the recovery of Remedy Services by All Professions. They are Change Operations that convert Victims from Remedy Disbelief into Remedy Belief and All Professions from Corrupt Service into Just Service. Most of the Remedy Belief Recovery will be the fact Simple Things happen. It needs Service Volunteers to do the Simple Things. Religion Leaders need to know what are the Simple Things and identify Service Volunteers who can do them. None of the Religious Leaders can do it alone.

## Simple Things

- Tell the Victim that Remedy Success needs Remedy Belief, Emotional Independence and Objective Judgement. Those who do not have Emotional Independence will need Emotional Support. It is better that they get it from their family and friends. They need to do as much as they can themselves. The Service Volunteers must not be over-burdened.
- 2. Tell the Victim that the Remedy Services are conditional on a Privilege Waiver and Confidentiality Waiver and Evidence Sharing Authority. Some cases will need Similar Fact Proof got by Other Cases. Evidence Sharing is the only way to get it.
- 3. Tell the Victim that Remedy Services need to make the best of the Basic Computer Skills of Elderly Volunteers.
  - 3.1. No one can predict the Probative Value of Any Document. Record Frauds got Forensic Test Material Status for Original Documents. Some will be Similar Fact Proof for Other Cases.
  - 3.2. Separate PDF Scans of All Paper Documents
  - 3.3. Efficient Labelling of All PDFs using YYYY MM DD + Case Description + Case Reference + Document Description + Parties. The computer folder puts them in chronological order. The labelling provides an overview that enables easy identification of Key Documents.
  - 3.4. Electronic Communications Logs that put everything in Chronological Order
- 4. Tell the Victim that Remedy Services needs the Evidence Record and one or more Interview Opportunities for a Case Analyst to produce a Case Explanation.
- 5. Tell the Victim that the Remedy Manager will need the Evidence Record, Case Explanation and Interview Opportunities to make a Remedy Plan and Case Management Authority

Religious Leaders need not do everything. They need some successes that force All Professionals to choose between Remedy Denial and Remedy Delivery. Most will choose Remedy Delivery. Some of the Retired Professionals will be Service Volunteers.

Good Management by Religious Leaders will deliver what many consider to be a Modern Miracle. It will change everything. It will provide a new basis for engagement with the Good Will Religions. Corruption Remedies for Victims will get Spiritual Renewal for many others. Make the best of it.
