In 2002 he used a Residential Tenancy Discount to buy a Long Lease Title to the Ground Floor Flat known as 25 Ferndale Court, Belfast with No Mortgage. He saved money for gradual Modernisation Refurbishment.
- 4. In 2002 his Mother, Mrs Helen Barr, made a Will with an Executor Appointment for her Son, Citizen Mr David Barr and her Daughter, Mrs Linda Martin and gave them Equal Shares. On 15th May 2012 she died. The Probate Estate Administration and Probate Contest got Fraud Conspiracy Proof for the Son, against the Daughter, State Officers, Court Officers, Representatives and Law Court Judges. A State Benefits Termination Fraud reduced his income to £20 a month. It forced him to rely on the generosity of friends. The Benefits Appeal got Appeal Fraud Proof, Rates Poverty Denial Fraud, Rates Enforcement Bankruptcy Fraud Proof, Bus Penalty Enforcement Fraud Proof, Court Fraud Proof and Co-ordinated Fraud Conspiracy Proof against State Officers, Court Officers., Representatives and Law Court Judges. The Coronation Oath Enforcement Authority used it for Dismissal Decisions against Prime Ministers Mrs May and Mr Johnson.
- 5. Citizen Mr Patrick Coyle, the Father, had a Speech Defect and Severe Dyslexia when he was a boy . It was a Severe Embarrassment to Mr John Coyle, the Grandfather. He used Regular Beatings as an Embarrassment Remedy. until the Powerful Physique of the father made it a Bad Risk. The Grandfather, managed Paedophile Entrapment Frauds and Paedophile Framing Frauds for the Protection Fraud Network. The Father achieved Justice Maturity and Emotional Independence before puberty. It enabled him to survive Regular Beatings until his Physical Development broke the Beating Confidence of the Grandfather. The Father achieved adulthood with a Normal Personality. The Father knew Unusual Facts but did not have the Interest or Expertise needed for Paedophile Entrapper Suspicions. The Grandfather did not know, was Chronically Insecure and feared Corruption Exposure by the Father.
- 6. In 2014 the Protection Fraud Network used a Business Expansion Plan to avoid Total Collapse. It used Family Sabotage Frauds and Child Thefts to get Big Budgets and Budget Fraud Profits with Extradition Frauds to get Money Laundering Services from Sovereign States. The Grandfather used the Chronic

The Repeat Request, Appeal Intent Notice and Appeal Form Request got a Disclosure Denial Fraud + Consent Waiver Fraud + Child Passport Consent Fraud by the Court for the Mother against the Father, and Wrong Appeal Form Supply Fraud by Court Officers against the Father. The 1st Appeal Notice of the Father got a 2nd Appeal Rejection Fraud for failure to use the Wrong Form by Court Officers, and then an Appeal Time Expiration Pretence Fraud. A Corruption Complaint and an Appeal Notice on the Wrong Form got a Confidence Collapse and 1st Appeal Acceptance and £98 Appeal Fee Request by Court Officers.
