 - 1.1. The Poverty Reason of No Money for the Electricity Meter denied an Electricity Supply.

 - 1.2.1.The Abdominal Diseases are Kidney Stones that might or might not affect or aggravate Cromes Disease + Irritable Bowel Syndrome + Pile Blockages of the Anus.
 - 1.2.2.Lung Disease
 - 1.2.3. The Spinal Injury from a Coccyx Fracture
 - 1.3. The Limited Case Management Capacity caused by Corruption Complexity and Corruption Stress
- 2. The Electricity Supply Failure got Cold Conditions that
 - 2.1. Aggravated the Abdominal Diseases and Lung Diseases.
 - 2.2. Created an Immediate Toilet Access Need that made him a Home Prisoner.
 - 2.3. Forced him to rely on his bed to stay warm
- 3. The Limited Case Management Capacity got the Agreed Remedy that Citizen Mr Stephenson act as Communication Agent between the Law Courts and Citizen. The Court of Appeal ignored the Agreed Remedy and sent the Hearing Notice to the Citizen instead of the Communication Agent.
- 4. The Court Enforcement Officer sent Enforcement Notice Emails to the Communication Agent
- 5. Corruption Exposure Warnings by Prime Minister Mr Sunak to the European Leaders used Internet Publicity by Citizens. Case Use Authorities from Citizens gave Prime Minister Mr Sunak a choice. He could include then in Official Communications, or refer European Leaders to Internet Publicity given by equitygovernance.uk. It got Remedy Co-operation from the European Leaders. They abandoned the Union Sabotage Plan and the Customs Barrier between Northern Ireland and the rest of the UK. It got the Windsor Agreement that could have been got in 2016. It got the Forced Resignation of Scottish Leader Ms Sturgeon before exposure of Framing Fraud Blackmail by her that silenced Political Opponents
