The Recovery Plan included sharing with Good Will Religions the responsibility for providing Lord Bishops to service the Coronation Oath Enforcement Authority. It needs careful management. The Lord Bishop Candidates need Common Law Expertise for Coronation Oath Enforcement. British Citizens developed Advanced Electronic Signature Technology. It enabled the Citizen to get control the Identity Market. It enabled use of the Core Identity Businesses to finance Education Trusts and Professional Development Trusts for Good Will Religion Leaders to qualify as Lord Bishops. The European Leaders used Market Exclusion Frauds to stop it. Success now will enable resumption of the plan.
