Norther n Ireland Police used a Complaint Pretence Fraud for an Assault Framing Fraud against Citizen Mr Barr. The Assault Trial got an Assault Denial Testimony and Complaint Denial Testimony by the Alleged Victim. It was Contempt Fraud Proof against Northern Ireland Police. It got Contempt Immunity fraud Proof against the Law Courts.

The Bank of Ireland had Bad Debts. They used Lord Justice Mr Horner to manage Court Frauds and used the Crime Proceeds for Bad Debt Repayment Frauds.

The Coronation Oath Enforcement Authority, Parliament and Cabinet needed Personal Responsibility Proof against Identifiable Individuals for Known Court Frauds for a Corruption Remedy Process. In Northern Ireland they needed Crime Business Management Proof and Framing Fraud Conspiracy Proof it against All Responsible Individuals up to and including Bank of Ireland Officers and Lord Justice Mr Horner.

The Probate Frauds + Bankruptcy Frauds + Enforcement Frauds against Citizen Mr Barr were excellent for the purpose. Corruption Proof got Dismissal Decisions against Law Court Judges. Dismissal Failures got Protection Fraud Proof against the Cabinet and Parliament until 2 By Election Defeats got a Confidence Collapse and Forced Resignation from Prime Minister Mr Johnson. It created the need for New Proof Sets under his successor. Prime Minister Ms Truss did not hold office long enough to get it. The Bankruptcy Possession Claim Fraud 21 0450650 and Corruption Claim 2022 100826 were used for Pending Adjudication Eviction Stay Application and Refusal Fraud Appeals that got it for Prime Minister Mr Sunak.

High Court Enforcement Officer Mr Healey and Northern Ireland Police Officers used the Eviction Fraud on 31st March 2023 for Theft of a Dog and Goods and more than £20,000 Cash that Citizen Mr Barr had withdrawn from the bank to buy a caravan. They used an Assault Framing Fraud as an Intimidation Fraud and Discredit Fraud against Citizen Mr Barr as a Protection Fraud for themselves. The Court Fraud Proof and Criminal Complaint are Relevant Evidence in the Fraud Appeal from the Court of Appeal to the Supreme Court. The Severe Disabilities of Citizen Mr Barr are Aggravation Evidence + Torture Proof.
