Crisis Conditions and Leadership Deals got the Premier Office for MP Mr Sunak and Retained Cabinet Office for Puppet MPs of the Protection Fraud Network. He needed to assert his authority. He used the Northern Ireland Peace Settlement and Brexit Negotiations.

The Peace Settlement was a Power Transfer from the UK State to the Northern Ireland Protection Fraud Network with Enforcement Commitments by the USA.

Prime Minister Mr Sunak needed a Northern Ireland Case to silence the Peace Settlement Enforcers in the USA and European Leaders. It needed to have enough money for Court Frauds by Top Judges but not enough, on its own, for Protection Frauds by the Northern Ireland Assembly and UK Cabinet.

The Ruin Frauds against Citizen Mr Barr were ideal for the purpose. He has Physical Incapacity

because of Lung Disease, Bowel Diseases and a Spinal Injury from a fractured coccyx, Simple Case Management Capacity, Complex Case Management Incapacity and lived alone. They underestimated him. He had the ability to make and keep friends in hard times. They used a Benefit Termination Fraud to get a Council Tax Liability Fraud and used that for the Bankruptcy Fraud. They used an Assault Complaint Pretence Fraud that got an Assault Trial and Assault Denial and Complaint Denial by the Alleged Victim. It was Contempt Fraud Conspiracy Proof against the Investigators and Prosecutors. It got Contempt Immunity Fraud Proof against the Law Courts. Citizens Mr Barr and Mr Coyle are friends. They have helped each other. The Case Use Offer + Leadership Deal Release Help Offer from Citizen Mr Coyle to Prime Minister Mr Sunak is Admissible Evidence for Parliament Session Decisions by the Coronation Oath Enforcement Authority.
