Charge: Assault + Surrender Failure Bail Breach Plea No Jurisdiction + No Liability

Defence: A Criminal Conspiracy invalidates the complaint, investigation and prosecution.

Counter Charge: Criminal Conspiracy for Fraudulent Breach of Fundamental Laws that govern the Justice Offices, Jurisdiction Limits and Case Priorities. Fundamental Law requires in every case:

1. A Credible Neutrality Qualification for the office of investigator, prosecutor, defender and adjudicator
2. A Credible Neutrality Breach invalidates process and gets a Remedy Only Jurisdiction Limit for the Victim against the Breach Manager and Breach Beneficiary
3. The Evidence Balance starts with a Validity Presumption for the Citizen and Credibility Presumption for the State both of which are subject to Rebuttal Proof Positive, and Fraud Proof of anything gets a Proof Burden Reversal on everything else for the Victim against the Fraud Managers and Fraud Beneficiaries
4. There is a Pending Remedies Enforcement Stay Protection + Remedy Only Jurisdiction Limit Protection from Superior Jurisdictions against All Inferior Jurisdictions
5. The Fundamental Law Breach Case of the Citizen has Case Priority over All Cases of All Others
6. A Validity Investigation to discover who has the Credible Neutrality Qualification for Justice Offices, what are the Jurisdiction Limits and what are the Case Priorities

The Coronation Oath Enforcement Authority managed a Corruption Remedy Process. It needed use of the truth, whole truth and nothing but the truth for Integrity Tests of the Authorities. Citizens gave Case Use Authorities. Equity Lawyer Mr Ellis provided Case Management Services. They got respectively, General Protection and Special Protection from the Crown and Parliament, with Protection Enforcement by the Cabinet and Enforcement Accountability by the Opposition Minority. The Integrity Tests got Fundamental Law Breach Fraud Conspiracy Proof against the State, Profession Authorities and Law Courts.

The Coronation Oath Enforcement Authority used the Fraud Proof to decide the Corruption Remedy Priorities for each Parliament Session. The 2022 Session Priority is Corruption Remedy Special Measures. Integrity Tests got Dismissal Executions against Sex Predators and Idiot Bullies and Protection Frauds for Framing Fraud Managers and Crime Business Managers. Records created the need for Personal Responsibility Proof against Identifiable Individuals.

Top Judges used Case Process Denial Frauds and Hearing Denial Frauds to avoid Audio Record Proof against them. They used Hearing Orders and Case Allocations that got Audio Records against

Validity Investigation Priority Finding + Conflicted Interest and Remedy Only Jurisdiction Limit Finding + Superior Jurisdiction Pending Remedies Enforcement Stay Protection and Inferior Remedy Only Jurisdiction Limit Finding + Conflict Disqualification Recusal + Conflict Qualification Fraud Finding + Conspiracy Finding + Contempt Finding + Remedy Entitlement Finding + Case Dismissal Order + Defence Costs with Indemnity Assessment Order for the Equity Lawyer against the State, General Osteopathic Council and Law Courts
