The Event + Event Evidence

The Crown Court is the Crime Scene. The Public Gallery Rights Case 20921 0540 Paper Records and Electronic Records are Criminal Conspiracy Proof. The Audio Record proves a Public Gallery Exclusion Order Fraud by the Hearing Judge, a Vacation Refusal and Police Involvement Requirement and Forced Removal Requirement, by the Equity, that prevented use of Arrest Fraud Contact for an Assault Framing Fraud, got an Enforcement Fraud that needed Public Gallery Criminal Trespass and an Arrest Fraud that was the 1<sup>st</sup> Assault, and then the Court Room Eviction Fraud by Police Constable 81229 Mr Richardson.

The Court Building Videos prove the rest. It is the 2<sup>nd</sup> Assault + Court Building Eviction Fraud + Bic Biro Casing Criminal Damage.

Standard Training requires State Officers to get Domination Satisfaction. They use Arrest Fraud Contact for Assault Framing Fraud to get it. The Court Audio Record of the Forced Removal Requirement denied it. Trivial Provocations get Temper Tantrums and Violent Assaults by Idiot Officers who do not know when to stop.

The Gentle Giant Security Guard, Equity Lawyer and PC Mr Richardson stood in a triangle. The Equity Lawyer had given Remedy Process Briefings to the Gentle Giant on previous occasions. Discrete Body Language was an Update Briefing Request by the Gentle Giant, who stood by the wall with his back to Court 1 Entrance Area. The Equity Lawyer faced the wall with the Security Guard on his left and PC Mr Richardson on his right. An Incident Record Request and Corruption Measures Test Case Warning by the Equity Lawyer got Standard Dismissal Domination Behaviour that was Idiocy Proof against PC Mr Richardson. He did not notice the Discrete Body Language. Repeated Eviction Fraud Call Touts by PC Richardson did not get an Eviction Fraud Call by the Gentle Giant. Remedy Process Update Comments by the Equity Lawyer to both of them got Dismissal Domination Responses by PC Richardson. The statement 'I will talk to him', or

something very similar, and a small movement by which the Equity Lawyer faced the Gentle Giant and the turned his back on PC Richardson was Trivial Provocation. It got the statement ‘how dare you turn your back on me’, or something similar, and a 2<sup>nd</sup> Violent Assault + Eviction Fraud by PC Richardson from the Court Building. The Eviction Event got a Body Electronic Evidence Claim by PC Richardson. It got Body Electronic Evidence Disbelief, or if there was, Evidence Access Disbelief by the Equity Lawyer. The Gentle Giant followed them. Repeat Touts that did not get an Eviction Fraud Call got Minor Assaults at the Court Door. A Brief Grunt by the Gentle Giant was interpreted as a Perjury Support Commitment by PC Richardson. It gave him the confidence for the Final Assault that pushed the Equity Lawyer some distance from the Entry Door and the Bic Biro Casing Criminal Damage. Cataracts prevented the Equity Lawyer seeing where the Broken Casing was. PC Richardson indicated where it was. The Video Record will include the Broken Casing Pick Up by the Equity Lawyer.

**Remedy Process Recommendations**

Dangerous Unfitness Finding Recommendation + Dismissal Priority Recommendation + Dismissal Remedy Precedent Recommendation by Equity Lawyer Mr Ellis to the Coronation Oath Enforcement Authority for the People against All Officers who are responsible for the Public Gallery Rights Case 2020 0540 + 22 CA 10743 23 for the Stated Reason the Equity Lawyer has the Analysis Skills and Communication Skills to explain the Domination Behaviour. Most people do not have it. On 17<sup>th</sup> March 2023 and 17<sup>th</sup> April 2023, the Osteopath Misdescription Fraud Appeal 2022 0062 Re-Trial and the Public Gallery Rights Case 2021 0540 got Audio Record Proof of Protection Fraud Calls by Law Court Judges that got Public Gallery Criminal Trespass by West Mercia Police and Essex Police. It got a Court Room Assault Complaint Fraud by the 2022 0062 Usher, Clerk, Appeal Judges and Arrest Fraud + Investigation Fraud + Corruption Remedy Special Measures Test Case Notice Rejection Frauds + Charge Fraud + 32 Hours Forced Wakefulness Torture + Dialysis Treatment Delay Torture by West Mercia Police. The 2021 0540 Assault + Eviction Fraud was trivial by comparison. The Idiot Bully Mindset + Poor Mood Control of Essex Police Constable 81229 Mr Richardson is Very Dangerous. The Remedy Process needs Idiot Bully Dismissal Precedents. The Public Gallery Rights Cases are excellent for the purpose.
