- 4. The European Union Rejection Majority and Dismissal Executions of Law Court Judges would have got the Windsor Agreement, or something similar by Christmas 2016. It did not happen. Prime Minister Mr Cameron led the Remain Campaign, lost and resigned. It was an Honourable Resignation. The Protection Fraud Network bought Leadership Votes for Candidate MP Mrs May because she was one of them. It got a 7 Year Delay for the Dismissal Executions.
