- 2. On 27th March 2023 the Assault Framing Fraud 2022 0043 Trial got an Audio Record of a Criminal Conspiracy to use Innocence Evidence Concealment Frauds and Hearing Notice Denial Frauds for a Secret Trial Fraud with intent to use the Appearance Failure for an In Absence Trial Fraud. It failed because a Confidence Collapse by Court Officers got a Hearing Notice 5 days before the Secret Trial and a Case Refusals by 100 Crown Prosecutors. The Audio Record includes an Evidence Production Order Refusal Fraud and an Evidence Production Requirement Notice Order for the State against the Citizen.
- 3. On 14th April 2023 the Public Gallery Rights Case 2021 0540 got a Hearing Change from a Trial to a Case Management Hearing by the Trial Judge. A Case Enquiry Call by the Citizen discovered the Case Allocation and made Allocation Objection that got a Case Return to the Trial Judge.
- 4. On 17th April 2023 the Public Gallery Rights Case 2021 0540 got an Audio Record that is Trial Fraud Proof against the Trial Judge. It includes a Dock Entry Demand Fraud and Representation Bench Equality Denial Fraud, both of which failed because the Citizen ignored them. It includes an Equity Lawyer Witness Protection Refusal Fraud. It includes an Evidence Production Order Breach Contempt Immunity Fraud and a 7 Day Adjournment for the State to make Innocence Evidence Concealment Fraud Arguments. Also, it got Audio Record Proof of a Similar Fact Public Court Room Exclusion Fraud against the Equity Lawyer who was a Public Gallery Witness. The Trial Judge has Joint Liability for the Violent Eviction Fraud against the Equity Lawyer by Essex Police Constable 81229 Mr Richardson that is evidenced by the Video Records of the Waiting Area and Reception Area. The Crime Complaint Statement dated 19th April 2023 of the Equity Lawyer explains it.
- All of it got a Confidence Collapse by the Court of Appeal in Protection Denial Frauds against the Equity Lawyer and Fraud Appeal 2023 000569 Issue Notice + Protection Application Urgent Listing for 3rd May 2023
- 6. The 2021 0540 Adjourned Hearing is the last chance the Trial Judges has for Contempt Fraud Remedy Orders for the Citizen before the Fraud Appeal Hearing and the Dismissal Executions against Law Court Judges by Parliament
