Remedy Process Test Case Notice + Fundamental Common Law Breach Contempt Penalty Warning for the Parliament Sessions Court to State Officers, Law Officers and Law Court Judges

Grounds: Fraudulent Breach of Natural Justice + Human Rights + Overriding Justice Objective

## Remedy Proposals

1. Fundamental Common Law Breach Case Finding + Case Priority Finding + Basildon Railway Ticket Barrier Event Location Finding + Event Video Finding + Video Single Frame of Ticket Barrier Leap Finding + Entire Video Production Repeat Order Finding + Repeat Order Breach Contempt Finding + Contempt Penalty Failure Finding + Contempt Immunity Finding + Credibly Neutral Adjudication Breach + Conflict Jurisdiction Disqualification Finding + Bias Finding + Fundamental Common Law Breach Finding + Trial Fraud Finding + Conspiracy Finding + Contempt Findings + Remedy Entitlement Finding + Remedy Priority Finding + Case Dismissal Order + Contempt Investigation Order + Investigation Reference to the Cabinet Order for Citizen Mr Nkrumah against the State for the Stated Reasons

## Stated Reasons

1. A Corrupt Deal used many thousand Tenancy Forgeries as Fraud Commitment Proof from Housing Association Officers to get Protection Fraud from Top Judges. Tenancy Forgery Complaints by Tenant Mr Nkrumah motivated Protection Frauds Demands by Housing Officers. A Protection Fraud Call by Top Judges got Framing Frauds by the Metropolitan Police against Mr Nkrumah. A Profit Share Demand by Top Police got a Profit Share Refusal and Framing Fraud Expert Resource Allocation Refusals by Top Police. Case Management Frauds by the State and Law Courts got Complaints + Applications + Claims by Mr Nkrumah. Ruin Fraud Calls by Housing Officers and Court Officers got Service Refusals by Competent Police Officers and Framing Fraud Services by Idiot Police Officers.
2. The Complaints + Applications + Claims got Forensic Test Material for Record Fraud Investigations. It was Original Document Seal Ink and Computer Record Inconsistencies.
3. In January 2020 Mr Nkrumah discovered the Coronation Oath Enforcement Authority, have a Confidentiality Waiver, Privilege Waiver and Case Management Authority for Integrity Tests of the Authorities. It got Integrity Test Judgment Services by Equity Lawyer Mr Ellis that got Corruption Remedy Standard Proof Sets that got Trial Orders by the Crown and Corruption Remedy Decisions by the Parliament Sessions Court.
4. The Remedy Process used Shop Theft Case to reveal that Original Document Seal Ink was Forensic Test Material for Record Fraud Investigations. It motivated Original Document Theft Plans by Top Judges. They needed Original Document Location Reports to issue Document Theft Orders. In September 2020 a Court Hearing revealed that Citizen Mr Nkrumah kept Original Documents in a Big Bag. An Original Documents Location Report by Court Officers got a Big Bag Theft Order from Top Judges and a Big Bag Snatch Theft outside Seven Kings Station on the Return Journey.
5. The Idiot Officers used an Athletics Training Whistle Possession for a Police Officer Impersonation Framing Fraud.
6. In January 2021 the Idiot Officers used a Half Eaten Shia Butter Packet for a Suspicious White Substance Frauds for a Drug Crime Framing Fraud because they did not have a Drug Supply for Evidence Planting. The Arrest Fraud

- + Investigation Fraud + Family Sabotage Bail Conditions Fraud against Citizen Mr Nkrumah and his Common Law Wife + Child Protection Frauds by Local Authority Officers. Bail Conditions Appeals by them got Case Resistance by Crown Prosecutors until a Confidence Collapse + No Contest got Immediate Return of the 3 Children by Local Authority Low Rank Officers + Continued Protection Frauds by High Rank Officers.
7. In June 2021 Uninsured Driving Trial got Legal Assistance from Citizen Mr Nkrumah for the Victim. It got an Assistance Prohibition + Representation Bench Use Prohibition Order + Public Gallery Banish Order by the Judge against Citizen Mr Nkrumah. He was the Sole Public Gallery Witness. An Adjudicator Identification Demand by the Victim got a Temper Tantrum Response from the Judge. He left the court room and went into the Judge's Chamber. He made a Secret Public Gallery Clearance Order Fraud to get Essex Police to remove Citizen Mr Nkrumah and stop him from witnessing the Trial Frauds. It got Criminal Trespass and an Assault Pretence Fraud + Arrest Fraud + Investigation Fraud + Charge Fraud by Essex Police. On 5<sup>th</sup> July 2021 the Public Gallery Rights Plea Hearing got an Event Fraud Report by Equity Lawyer Mr Ellis for the Parliament Session Court. Report Service on the State and Court got a Confidence Collapse and use of a Secret Hearing on 7<sup>th</sup> July 2021 for a Case Transfer from Essex to Hertfordshire. The 1<sup>st</sup> and 2<sup>nd</sup> Public Gallery Rights Hertfordshire Plea Hearings got a Committal Order to the Crown Court and Event Fraud Reports by Equity Lawyer Mr Ellis to the Parliament Sessions Court and Jurisdiction Fraud Finding + Contempt Remedy Denial Fraud by between 30 and 50 Crown Court Judges that are evidenced by Case Transfers from St Albans to Chelmsford, and then to Basildon then in 2023 to Snaresbrook.
  8. In November 2021 the Framing Fraud Farces + Public Gallery Rights Case + Forensic Test Material motivated a Corruption Investigation Sabotage Plan by Top Judges. It needed a Witness Discredit Fraud against Citizen Mr Nkrumah and Computer Theft + Record Inconsistency Evidence Destruction. They procured an Eviction Fraud + Computer Theft by a Private Landlord the day before the Public Gallery Plea Hearing in Basildon. They planned an Assault Framing Fraud at Basildon Station on the Return Journey.
  9. Everything that could go wrong for the Top Judges did go wrong. Idiot Officers relied on the Private Landlord for the Computer Theft + Evidence Destruction and an Eviction Site Exclusion Bail Condition Fraud to stop Stolen Computer Recovery by Citizen Mr Nkrumah. He ignored the Bail Condition, visited the Eviction Site, noticed the Stolen Computers in the Rubbish Skip. A Theft Complaint + Stolen Goods Recovery Call that got a Police Attendance and Recovery Refusal Fraud + Arrest Fraud + Framing Fraud Trial 2022 0043 + Secret Trial Fraud Plan by Top Judges. It used Hearing Notice Denial Frauds to get a Trial Appearance Failure + In Absence Trial Fraud + Conviction Fraud + Arrest Warrant Fraud. It failed. On 22<sup>nd</sup> March 2023 a Confidence Collapse by a Court Officer got a Trial Date, Case Refusals by more than 100 Crown Prosecutors, Trial Appearances on 27<sup>th</sup> March 2023 by the Framing Fraud Officers and Citizen, and Audio Records that Secret Trial Fraud Conspiracy Proof.
  10. The Witness Discredit Fraud failed. Citizen Mr Nkrumah is Physically Fit. He avoided the Physical Contact needed for the Assault Framing Fraud. He put his hand on the Ticket Barrier, used it as a pivot and leapt over it. The Ticket Barrier Video Record is No Contact Innocence Proof. The Prosecution File contains a Single Frame from the Ticket Barrier Video. His face was close to his hand and moved so little it was recognisable. His feet were a streak of light because they moved so fast. Video Evidence Production Applications got Repeat Video Evidence Production Orders + Repeat Order Breach Contempt Fraud Proof + Repeat Contempt Immunity Fraud Proof + Trial Fraud Conspiracy Proof against the Investigators, Prosecutors, Defenders Trial Adjudicators and Fraud Appeal 2023 0058 Delay Frauds by Supervision Judges at Basildon Crown Court.
  11. The Session Priority is Credibility Recovery for the Authorities. It needs Dismissal Executions by a United Parliament, Victim Identification and Case Remedies. In 2024 Parliament used scandals to get Mass Publicity for Corruption Exposure to Cabinet Level Remedy Obligations of Fraud Profiteers and Mass Remedies. The Remedy Process needed Test Cases to discover what impact if any Mass Publicity had on Case Management. All Test Cases managed by Equity Lawyer Mr Ellis got Corruption Continuity Proof against Fraud Profiteers, State Officers, Law Officers and Law Court Judges. Parliament got Mass Publicity for Honourable Parliamentarians who had serviced the Remedy Process. Test Cases got Audio Records that are Personal Responsibility Proof against Identifiable Individuals for Known Frauds. The High Court 2020 002595 + 2024 000705 Contempt Remedy Applications of Citizen Mr Nkrumah got Audio Records that are Personal Responsibility Proof against Justice Mr Bourne for the Known Ruin Frauds against Citizen Mr Nkrumah. Criminal Investigation 01 YE 15441 23 used the Ruin Frauds for a Relevant Issues Notice. It got Investigation Fraud Proof against the Metropolitan Police.
