

2023 0058 Case Management Hearing Fraud Report of Equity Lawyer

## Basildon Crown Court 3

Police Officer Mr Zamad was sat outside Court 3. Equity Lawyer Mr Ellis sat, engaged him in conversation and began a Remedy Process Briefing. Crown Counsel appeared and suggested that Officer Mr Zama go to the Police Room. Officer Mr Zama got up, said to the Equity Lawyer he would be back, and left. The Equity Lawyer did not believe him. The Court 3 Case was Trial 2024 0724 of R v Ms Darcy Thomas. The Equity Lawyer entered Court 3. A Case 2023 0058 Remedy Application Print Offer by the Equity Lawyer got an Offer Refusal by Crown Counsel. The front row of the Public Gallery had writing tables. A Middle Aged Woman was sat in the front row seat that was most distant from the Court Room Door. Event discovered she was the Defendant's Mother. Occupation of a Public Gallery Rear Seat near the Court Room by the Equity Lawyer got Objection Behaviour by the Middle Aged Woman and an Investigation Effort by the Equity Lawyer. Citizen Mr Nkrumah arrived in time to witness the Court Building Eviction Fraud. The Equity Lawyer gave him an Event Briefing and the 2023 0058 Application Prints and told him where he would wait.

The Fraud Appeal 2023 0058 Hearing got a Conflict Disclosure Failure Fraud by Mr Peter Hoche and Case Dismissal + Contempt Remedy Application Hearing Denial Fraud + 8 September 2023 Adjournment Fraud for the framing Fraud Conspirators against Citizen Mr Nkrumah by Recorder Ms Harrington + Magistrates Mr Peter Hoche + Mr Adrian Rutter. An Application Filing Stamp Proof Request got a No Stamp Response and a Handwritten Receipt by an Unidentifiable Court Officer on Multiple Originals. The Café Meeting got an Officer Identification Request by the Equity Lawyer.

A Crown Court Visit by both of them got identification of Court Officer Ms Collard + Adjournment Date Change from Sunday 8 September 2024 to 8 November 2024 + Emigration Notice from Case Officer Ms Honey Young for a for Citizen Mr Nkrumah. It got a Remedy Process Briefing Start from the Equity Lawyer for the Security Manager and then a Premature End got by the Appearance + Contact Request Words + Behaviour by Trial 2024 0724 Defendant Ms Darcy Thomas and the Middle Aged Woman got an Email Address Request by the Equity Lawyer who offered the newspaper as Writing Material. It got the comment 'they are needed elsewhere' [or something similar] by the Security Manager or someone else. It got Hesitant Behaviour by the Ms Darcy Thomas and the Middle Aged Woman and a Hasty Eviction Fraud against the Equity Lawyer by the Security Manager.
