CITIZEN CASE EXPLANATIONS of the Conflict Jurisdiction Disqualification Defence + Counter Charge

It used Family Sabotage Frauds + Children Thefts to get Big Budgets + Budget Fraud Profits and Expatriation Frauds to get Money Laundering Services by Sovereign States. The Family Sabotage Frauds + Child Protection Frauds against Citizen Mrs Theodorou and the 6 Children were the Business Priming Case. In 2024 the Corruption Remedy Process used Mass Publicity for Corruption Exposure and Mass Remedies and Test Cases to discover what impact it had on the Case Management. All Test Cases managed by Equity Lawyer Mr Ellis got Corruption Continuity Proof against Fraud Profiteers, State Officers, Law Officers and Law Court Judges. The Criminal Investigation 01 YE 15441 23 Tests got Case Process Denial Fraud Conspiracy Proof for Citizen Mr Antonakis Katsiaounis against the State and Law Courts. It is Similar Fact Proof to that got by Family Sabotage Frauds. On Friday 12th April 2024 between 10.30 and 11.30 Child Case ZW23C50347 got Audio Records in Royal Court 43 that are Child Care Fraud Proof + Remedy Denial Fraud Proof for the Complainant + All Case Victims + All Others against Justice Mr Moore and Joint Conspirators. The Corruption Cases are a Common Interest that needs Evidence Sharing and Co-ordinated Management by All Family Members including the Complainant and the Accused who is her Maternal Grand Father. He has Key Source Status for Old Family History that is Relevant Evidence. Fair Process needs All Victims to have Free Access to All Relevant Others to decide Case Management Priorities, even if some of them do not use it. The Bail Breach Complaint dated 12/04/2024 by the Complainant's Mother, Citizen Mrs Theodorou, got Response Emails and No Remedial Action that is Process Denial Fraud Proof for All Interested Parties against the Case Officer. The Response Emails at 14.05 on 16/04/2024 reads 'In regards to Mr Edward Ellis I have been receiving correspondence from him with documents that have mine and your name on it and I'm not really sure what they relate to.' It is either a Confusion Misrepresentation Fraud or Case Management Incapacity Proof against him.

Previous Bail Conditions Revocation + Contempt Remedy Application dated 24th January 2024 got Process Denial Fraud Proof for Citizen Mr Katsiaounis against the State Paid Defenders, Tucker Solicitors, Case Officer Detective Constable Mr Jake Flanders and the Magistrates Court.
