## Stated Reasons

The Parliament Session Court decides the Corruption Remedy Priorities for each Parliament Session. The Session priority is Credibility Recovery by the Authorities. It needs Dismissal Executions against Top Judges by a United Parliament, Victim Identification and Case Remedies. Remedy Sabotage by Corrupt Parliamentarians denied a Untied Parliament. It created the need for Forced Unity. It needed Imprisonment Fraud Proof and use of it for an Unfit Judiciary Finding + Political Prisoner Finding + Protection Fraud Finding + Enforcement Fraud Finding and Corruption Exposure Blackmail of the Corrupt Parliamentarians by the Parliament Session Court to get Finding Pronouncements by Opposition Leader Sir Keir Starmer and Parliament Committees that got Mass Publicity respectively in May, July, August and September 2023. The G7 Summit in December 2023 got a Secret Agreement for Remedy Enforcement against Fraud Profiteers. In 2024 Mass Publicity for Corruption Exposure to Cabinet Level, Remedy Obligations of Fraud Profiteers and Mass Remedies by Parliament. The Remedy process needed Test Cases to discover what impact Remedy Publicity had on the Case Management. All Test Cases managed by Equity Lawyer Mr Ellis got Corruption Continuity Proof against Fraud Profiteers, State Officers, Law Officers and Law Court Judges. Crown Court Judges used Adjournment Frauds until after the 2024 Parliamentary General Elections. Criminal Investigation 01 YE 15441 23 Frauds used Bail Conditions Appeal Process Denial Frauds + Court Fraud Proof Exclusion Frauds + Delay Frauds. The Housing Benefit Renewal Claim was an Enforcement Fraud Test Case. Claim Records got No Sound Judgment by the Defendants until Rent Arrears Enforcement Telephone Call got an Oral Briefing + Panic Reaction + Partial Remedy.
