Corrupt Business Expansion Plans use Business Priming Cases to get Fraud Knowledge Admissions and Remedy Denial Fraud Commitments from All Relevant Professionals. A Business Expansion for Industrial Scale Land Frauds used Business Priming Cases for Big Land Owners against Small Businesses. Good Case Management by a Farm Tenant and a Town Tenant got complete sets of Land Fraud Proof. Citizen Mr Can Say was the Town Tenant.

The Coronation Oath Enforcement Authority has Corruption Control Jurisdictions that govern Parliament Session Powers. They decide the Corruption Remedy Priorities for each Parliament Session. They have managed a Corruption Remedy Process. Service of the Corruption Remedy Process by Citizen Mr Say motivated a series of Taxation Frauds by Corrupt Officers. Good Case Management by Citizen Mr Say got series of Confidence Collapses and Taxation Fraud Terminations.

The Session Priority is Credibility Recovery for the Authorities. They decide the Corruption Remedy Priorities for each Parliament Session. It needs Dismissal Executions against Top Judges by a United Parliament, Victim Identification and Case Remedies. Remedy Sabotage by Corrupt Parliamentarians denied a United Parliament. It created the need for Forced Unity. It used Imprisonment Fraud Proof for an Unfit Judiciary Finding, Political Prisoner Finding, Protection Fraud Finding and Enforcement Finding. It needed Exposure Blackmail to get Mass Publicity for Finding Pronouncements by Opposition Leader Sir Keir Starmer and Parliament Committees, Corruption Exposure and Corruption Remedies.

Test Cases by Citizens got Corruption Continuity Proof against Fraud Profiteers, State Officers and Law Court Judges. One of the Test Cases is a Taxation Fraud by Corrupt Officers.
