#### Contempt Penalty Warning to All Officers of All Authorities for the Parliament Sessions Court

Stated Reasons

The Coronation Oath Enforcement Authority has Corruption Control Jurisdictions that govern Parliament Session Powers. They used Endemic Corruption proof for a Remedy Process. It needed Credibility Recovery for the Authorities using Dismissal Executions against Top Judges by a United Parliament, Victim Identification and Case remedies. Remedy Sabotage by Corrupt Parliamentarians denied a United Parliament. It created the need for Forced Unity. The Parliament Sessions Court used Imprisonment Fraud Proof for an Unfit Judiciary Finding + Political Prisoner Finding + Protection Fraud Finding + Enforcement Fraud Finding and Corruption Exposure Threats to get Finding Pronouncements in 2023 by the Opposition Leader Sir Keir Starmer and Parliament Committees. The G7 Summit got an International Agreement for Remedy Enforcement against Fraud Profiteers. The Parliament Sessions Court required use of the Post Office Scandal and Health Scandals to get Mass Publicity for Corruption Exposure and Mass Remedies. Test Cases got Corruption Continuity Proof against Fraud Profiteers, Officers and Judges. Election Fairness in the 2024 General Election needs the Remedy Orders and Positive Mass Publicity for the Citizen Claimant and All Victims.
