Remedy Process + Election Integrity Test + Special Service Request from Equity Lawyer to Officer 3rd June 2024

From Equity Lawyer Mr Edward Ellis To Metropolitan Police Officer Mr Tomass Kuprejevs

Dear Tomass,

I hope migration to the United Kingdom and Police Service has been a Pleasurable Success for you. The Parliament Sessions Court needs a Special Service by someone with a Special Credibility Qualification. You have it. The Special Service needs a Case Reference Email from the Qualified Officer to All Superiors including Metropolitan Police Commissioner Sir Mark Rowley. A Case Reference Total Failure will imply that you have Corruption Suspicions against the Command Chain. A Case Reference to some will imply you have Corruption Suspicions against all others. Accordingly, the Special Service needs a Case Reference to All Superiors including Metropolitan Police Commissioner Sir Mark Rowley. Those who do not know the case history will need an explanation of it.

The Coronation Oath Enforcement Authority has Corruption Control Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority Responsibilities of Parliament. The Session Powers are the Enforcement Powers. They got Corruption Proof against the State, Remedy Denial Fraud Proof against the Law Courts and Protection Fraud Proof against the Cabinet and Parliament. In 2019 they used it for Dismissal Decisions against Prime Minister Mrs May and Parliament. It got a Forced Resignation from her and the Forced Winter General Election. It motivated Reassurance Demands by Fraud Profiteers and Corrupt Officers that got Forced Protection Frauds from Top Judges. It got Confidence Collapses by Court Officers, Money Launderers and Top Judges in the capacity of the Law Courts to deliver Protection Frauds. They needed Internet Publicity for Intimidation Frauds against a Victim as a Claim Deterrent against Many Victims.

The Lawful Business of Citizen Mr Cant got Money Laundering Fraud Proof against Hackney Council and Protection Fraud Proof against the Metropolitan Police and Law Courts. He had a Low Stress Threshold. His Stress Response was use of Internet Publicity to inform the Corruption Victim Community. It got Obvious Target Status for him. The Intimidation Frauds were Kill Threats + Grievous Bodily Harm by Professional Thug Mr Seton who was part of the Kenneth Noy Crime Gang. The Event Proof was Video Records + Audio Records + Hotel Meeting Room Records + Event Witness Testimony.

In May 2019 Kill Threats + Grievous Bodily Harm Crime Complaints by Citizen Mr Cant got Investigation Denial Fraud Proof against the Metropolitan Police. Violent Harassment Restraint Protection Claims and Appeals got Protection Denial Fraud Proof for Citizen Mr Cant against the County Court, High Court, Court of Appeal and Supreme Court. The Fraud Appeal Grounds dated 31st July 2020 got Supreme Court Case Reference 2020 0186. A Minimum Charge Protection Fraud Call by Top Judges got use of the Kill Threats + Grievous Bodily Harm Crime Complaint Investigation + Event Evidence Exclusion Fraud Orders + Common Assault Case Classification

Remedy Process + Election Integrity Test + Special Service Request from Equity Lawyer to Officer 3rd June 2024

+ Common Assault Charge against Professional Thug Mr Seton before the Appeal Dismissal Fraud by the Court of Appeal. The Corruption Remedy Process Case Notices in the Court of Appeal and Supreme Court got Confidence Collapses in the Ministry of Justice and a Common Assault Re-investigation Request by Crown Prosecutors. It got a Case Management Meeting for the Citizen Mr Cant and Investigator Mr Kuprejevs, a Meeting Invitation by Citizen Mr Cant, a Meeting Attendance by Equity Lawyer Mr Ellis and an Investigation Assistance Agreement for the Event Witness Interview by the Equity Lawyer. It got the Remedy Process Notice + Immunity Application + Evidence Offer dated 16th February 2020 of Mr Lawrence Glen Brightman. Filing it by the Metropolitan Police got a Confidence Collapse + Immediate Case Withdrawal by the Crown Prosecutors. They were Good Decisions by the Investigator and Prosecutor. The Fraud Appeal 2020 0186 Decision Document dated 15th November 2021 is a Protection Fraud Call by Supreme Court Judges to the Cabinet. The Special Credibility Qualification is use of Investigator Status + Police Uniform that got Protection Fraud Proof against Top Judges including the Protection Fraud Call from the Supreme Court to the Cabinet. The Parliament Sessions Court used the Protection Fraud Proof for Dismissal Decisions against Top Judges. In 2021 Dismissal Failures were Protection Fraud Proof against the Cabinet. The Default Penalty was a Dismissal Decision against Prime Minister Mr Johnson. Dismissal Help requests by Governing Majority MPs got Help Refusals by Opposition Leader Sir Keir Starmer because he provided Protection Frauds when he was Director of Public Prosecutions. He used the Covid Party Scandal for Dismissal Effort Pretences while managing the Dismissal Refusal Frauds. It denied the United Parliament needed for Credibility Recovery by the Authorities. It created the need for Forced Unity. Prime Minister Mr Sunak and Metropolitan Police Commissioner Sir Mark Rowley made Corruption Remedy Commitments when they got office. Forced Unity needed Imprisonment Fraud Proof for a Judiciary Unfitness Finding + Political Prisoner Finding + Protection Fraud Finding + Enforcement Fraud Finding. In 2023 Corruption Exposure Threats got Finding Pronouncements by the Opposition Leader and Parliament Committees. In December 2023 the G7 Summit got an International Agreement for Remedy Enforcement against Fraud Profiteers. In 2024 the Post Office Scandal and Health Scandals got Mass Publicity for Corruption Exposure to Cabinet Level and Mass Remedies by Parliament. The General Election Call changed the Publicity Focus from Past Corruption to Future Remedies. The Remedy Process needs Election Integrity Tests. The Judicial Review gives Interested Party Status to Political Party Leaders. It gives all of them Equal Status for Remedy Action in the Election Campaign Period. The Special Service is a Kill Threats + Grievous Bodily Harm Criminal Investigation Re-Opening Request Email from the Investigator to All Superiors including the Metropolitan Police Commissioner with the Remedy Co-operation Proof of a Copy Email to Equity Lawyer Mr Ellis.
