

Remedy Process + Election Integrity Test + 17th and 18th Interested Party Status Proposal

Before Justice

Upon reading the Judicial Review Claim Papers and Interested Party Status Application of Mr Lee Cant

1. Corruption Victim Status Claim Finding + General Election Remedy Issue Finding + 17th and 18th Interested Party Status Order for Mr Lee Cant and Mr David against the Respondents for the Relevant Interest Reasons that:

- 1.1. Criminal Conspiracies by Fraud Profiteers use General Election Issue Denial Frauds and Non-Disclosure Propaganda Frauds by Political Party Leaders and Media Managers to get Mandate Protection Frauds by Remedy Denial Majorities in Parliaments. The choice for Honourable Individuals is Do Nothing or Remedy Hope Action. It needs Election Integrity Tests Claims by Honourable Victims that get either Remedy Agreement Publicity by Mandate Fraud Conspiracy Proof or Remedy Denial Fraud Conspiracy Proof that Honourable Politicians can use to get a Remedy Majority in Parliament.
- 1.2. The Election Integrity Test Claims get Claimant Status and Interested Party Status for Corruption Victims, and Liable Party Status for Authorities and Interested Party Status for Political Party Leaders. It gets Official Records of Election Issues.
- 1.3. The Corruption Claims of Mr Cant are:
 - 1.3.1. Housing Estate Maintenance Accounts by Hackney Council, Expense Questions by Mr Cant got Response Refusals + Fraud Remedy Action + Fraud Conspiracy Proof against Hackney Council, the Metropolitan Police, Property Tribunal and Law Courts.
 - 1.3.2. Accounting Service Fee Payment Denial Claims got Fraud Proof for Mr Cant against the Law Courts and Low Rank Criminals who have Organised Crime Connections
 - 1.3.3. Kill Threats + Grievous Bodily Harm got Violent Harassment Restraint Protection Fraud Proof for Mr Cant against Professional Thug Mr Seton, who works for the Kenneth Noy Crime Gang, the Metropolitan Police and Law Courts. It includes the use of the Supreme Court Fraud Appeal 2020 0186 for a Protection Fraud Call dated 15th November 2021 from Top Judges to the Cabinet.
 - 1.3.4. Disability Exploitation Frauds got Similar Fact Corruption Proof against the Northern Ireland State and Corruption Refugee Exile Status for Mr David Barr

2. Evidence Preservation Orders + Pending Remedies Enforcement Stay Protection Orders for Citizens Mr Cant and Mr Bar against the Respondents
