Judicial Review Case Progress Update Request for the Reason that

1. Endemic Corruption created the need for a Risk Control against Mandate Fraud Conspiracies by Political Party Leaders and Media Managers. It needs Election Integrity Test Cases that use Corruption Claims with Claimant Status and Interested Party Status for Victims and Defendant or Respondent Status for the Authorities and Interested Party Status for Political Party Leaders and Media Managers. The Test Case needs Urgent Process in the High Court and, if needed, the Court of Appeal before General Election Day which is on 4th July 2024.
2. Citizen Mr Lee Cant has agreed to apply for Court Fee Remission and make an Interested Party Status Applications for himself and Corruption Refugee Exile Mr David Barr.
3. Citizen Mr Barry Brooks has agreed to apply for Court Fee Remission and make an Interested Party Status Application for himself and Liable Party Status for the BBC. In 1999 a Scandal Investigation got Child Trafficking + Paedophile Finding by Journalist Ms Gill Dando and Protection Frauds by Prime Minister Mr Blair that used State Assets for the Murder of her and a Murder Framing Fraud against a Vulnerable Adult. The Fraud Appeal Acquittal for the Vulnerable Adult created the need for Additional Protection Frauds. Citizen Mr Brooks was one of the Charity Officers who provided Support Services for the Vulnerable Adult. The Additional Protection Frauds included Ruin Frauds against Citizen Mr Brooks. The Ruin Frauds included Defamation Frauds that used Crippling Injuries Denial Frauds + Severe Disability Denial Frauds + Asset Forfeit Frauds + Diving Photographs taken before he suffered Crippling Injuries were Benefit Claim Fraud Proof + Defamation Frauds as Sinner Evidence for an episode in the series Saints and Sinners.
4. The Gill Dando Murder and Ruin Frauds are Unfinished Business.
5. Fraud Proof of anything gets a Proof Burden Reversal and Fraud Presumption of everything else for the Fraud Victim against the Fraud Manager and the Fraud Beneficiary.
6. The use of Defamation Frauds by the State and Law Courts for the Sinner Defamation Frauds gets a Fraud Victim Status for Citizen Mr Brooks and Fraud Manager Joint Liability and Fraud Profiteers Status for the BBC
