REASON:

1. Medical Records are Health Fraud Conspiracy Proof + Murder Conspiracy Proof for Citizens against Top Officers. They needed Old Medical Records Destruction Frauds and New Remedy Denial Frauds. They made Identity Proof a GP De-registration Condition. They used Identity Verification Denial Frauds for Passport Denial frauds and Driving Licence Denial Frauds.

2. Passport Application PEX 530 360 8791 is Identity Verification Denial Fraud Proof for Equity Lawyer Mr Edward William Ellis against the Pass Port Office. Equity Lawyer Mr Ellis managed Corruption Investigations for the Remedy process managed by the Coronation Oath Enforcement Authority.

3. In 2006 the Corruption Investigations motivated Prime Minster Mr Blair to issue a Kill Order with conditions for No Missing Body + No Forensic Evidence. It needed Ambush Stress Conditions that got a Panic Reaction + Personal Injury and use of First Aid Pretences for Murder by a Secret Service Officer and then Accidental Death Finding Frauds by the Authorities. It failed. The Stress Conditions did not get the Panic Reaction + Personal Injury because the Equity Lawyer knew what was happening.
4. In 2014 it motivated Top Judges to issue a Kill Order to Known Dangerous Criminals. It needed a Mobile Phone Isolation Fraud that got Sent Records for Intercepted Texts and denied Call Connections by Communications Authorities and then Evidence Concealment Frauds by Sussex Police. It failed. The Equity Lawyer knew to expect it. He sent a text to someone a mile away, visited 30 minutes later, discovered the Sent Text had not arrived. Call Efforts got No Connection when others close by had Call Connections. It discovered the Mobile Phone Isolation. The Only Credible Purpose was a Hit Murder. The Equity Lawyer spent 6 hours in the supermarket, town centre car park and library. Sussex Police knew that the Secret Service collaborated with the Equity Lawyer. Sussex Police feared Event Records by the Secret Service would expose the Evidence Concealment Frauds. A Confidence Collapse got a Protection Fraud Refusal by Sussex Police and Murder Refusal by the Known Dangerous Criminals.
5. In 2018 and 2019 the Corruption Investigations motivated Hospital Kill Order by Prime Minister Mrs May needed Discredit Frauds against the Equity Lawyer as Protection Frauds for State Doctors. A Mental Examination Refusal by the Equity Lawyer got Health Service Blackmail that used Kidney Failure Treatment Denial Threats to support Mental Examination Consent Demands that got Repeat Examination Refusals and Blackmail Investigations by the Equity Lawyer that got Health Blackmail Fraud Proof against Top State Doctors and Protection Fraud Proof against Prime Minister Mrs May. In December 2019 a Poison Kill Order by Prime Minister Mr Johnson failed to get a Rapid Kill because the Equity Lawyer realised what was happening and achieved a Partial Remedy. Soon afterwards he suffered Kidney Failure. He thought Kidney Failure caused the Long Term Poison Damage. In November 2023 a Top Doctor a Poison Damage Diagnosis would get Ruin Frauds against him. The Poison Damage caused a Blood Pressure Reduction from 120/80 in 2020 to 90/60 in 2024 that is a Dialysis Treatment Water Removal Stop Trigger. Broomfield Hospital needed a Poison Damage Case Reference to avoid Dialysis Treatment Standard Practice servicing the Poison Damage Murder.
